PUBLICATIONS ACT, 1974

FILM

The Publications Appeal Board has under section 24 of the Publications Act, 1974, as amended, decided that the undermentioned film is not undesirable within the meaning of section 47 (2) of the Act by stipulating—

- (b) that the film is approved for indoor theatre and video distribution; and
- (c) that drive-in theatre distribution is not allowed.
