ADDITIONAL APPROPRIATION ACT (HOUSE OF ASSEMBLY),
1990

Act No. 19, 1990

ACT

To appropriate additional amounts of money for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1990.

(Assented to 9 March 1990.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Appropriation of additional moneys for requirements of Administration: House of Assembly

- 5 1. Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Assembly during the financial year ending 31 March 1990, as a charge to the Revenue Account: House of Assembly, the additional amounts of money shown in column 1 of the Schedule.

10 **Short title**

2. This Act shall be called the Additional Appropriation Act (House of Assembly), 1990.
