Act No. 20, 1990

ACT

To appropriate additional amounts of money for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1990.

(Assented to 9 March 1990.)*

BE IT ENACTED by the State President and the House of Representatives of the Republic of South Africa, as follows:—

Appropriation of additional moneys for requirements of Administration: House of Representatives

- 5 1. Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated for the requirements of the Administration: House of Representatives during the financial year ending 31 March 1990, as a charge to the Revenue Account: House of Representatives, the additional amounts of money shown in column 1 of the Schedule.

10 **Short title**

2. This Act shall be called the Additional Appropriation Act (House of Representatives), 1990.
