THE ADMINISTRATION AND CONTROL OF CERTAIN AREAS IN NATAL.—TOWNSHIPS BOARD—RATES AND TARIFFS

I, Pieter Grabriel Marais, Deputy Minister of Education and of Development Aid, do hereby make known, under the powers vested in me by Regulation 17 (3) (b) of the Regulations for the Administration and Control of Certain Areas in Natal, published under Proclamation No. 67 of 6 May 1983, that I have approved the bylaws set out in the accompanying Schedules adopted by the Townships Board to replace the rates and tariffs promulgated by Government Notice No. 1177 of 9 June 1989.

This Government Notice shall apply *mutatis mutandis* to all the townships referred to in Schedule A of Proclamation No. 67 of 6 May 1983.

BYLAE I

BELASTINGTARIEWE

1. Op elke perseel met 'n oppervlakte van hoogstens 1 000 m²: 'n bedrag van R50 per jaar en 'n verdere R0,10 per jaar vir elke addisionele m².

An amount equal to the actual cost of the repair or replacement of the meter.

(a) An applicant for a building permit shall pay in advance to the Townships Board the applicable amount set forth hereunder in respect of the supervision of the erection or alteration of or addition to any dwelling, building, outbuilding or other structure:

- (i) Works not exceeding 20 m² in extent R20,00.
 (ii) Works exceeding m² in extent: for each additional 10 m² or part thereof R4,50.

Should the application for a building permit be refused, the amount concerned shall be refunded.

(b) For purposes of subsection (a) "works" shall include any building operation or other construction work that is subject to inspection by the Townships Board.

7. BLOCKED SEWERS AND DRAINS

A consumer shall pay in advance to the Townships Board an amount of R15,00 for the removal by the Townships Board of any blockage in any sewer or drain: Provided that if the blockage is not due to any fault of the consumer, the said amount shall be refunded.

8. ALLOCATION OF PAYMENTS

Partial payments in respect of accounts will be allocated according to the following priority order:

- (i) Services other than electricity;
 (ii) electricity.

BYLAE III**BOETES**

1. Indien belasting en/of vorderings kragtens hierdie verordeninge betaalbaar, nie binne 30 dae vanaf die betaaldag betaal word nie, word 'n boete van 12% per jaar gehef vanaf sodanige betaaldag tot die datum van betaling.

2. By versuim om waterheffings betyds te betaal, stel 'n verbruiker hom daaraan bloot dat 'n drukdemperwaster in die watertoevoerpylp aangebring word, in welke geval, benewens die waterrekening, 'n bedrag van R10,00 betaalbaar is vir die verwydering van sodanige drukdemperwaster.

SCHEDULE III**PENALTIES**

1. If rates and/or charges payable in terms of the bylaws are not paid within 30 days of the due date, a penalty of 12% per annum shall be charged from such due date to the date of payment.

2. Failure to pay water charges in time shall render a consumer liable to having a pressure reduction washer fitted to the water supply pipe, in which event there shall be payable, in addition to the water account, a fee of R10,00 for the removal of such pressure reduction washer.
