#### 1. GOSFORTH TOLPLAZA.

- 1.1 Die bedrag van tol betaalbaar per motorvoertuig op die tolpad tussen die kruispaaie Rand Lughaweweg en Pad P6-2 (K109) Heidelbergweg is soos volg:

Further to Government Notices Nos. 1136 dated 2 June 1989 and 2750 dated 11 December 1989, the South African Roads Board hereby makes known for general information that the amount of toll that will be payable in terms of the aforementioned notices for a trip along portions of the Springs-Krugersdorp Expressway Toll Road (Route N17), shall be as detailed below:

#### 1. GOSFORTH TOLL PLAZA.

- 1.1 The amount of toll payable per motor vehicle on the toll road between the cross roads Rand Airport Road and Road P6-2 (K109) Heidelberg Road is as follows:

CLASS I: R0,70.  
CLASS II: R2,80.  
CLASS III: R3,80.  
CLASS IV: R5,30.

- 1.2 An additional levy of R50 will be charged on all abnormal vehicles.

2. A discount on the amounts of toll mentioned above is allowed to users who tender valid credit cards (Visa or Mastercard) and Fleet Management Cards, approved for this purpose by Toll Highway Development Company (Pty) Ltd, as set out hereunder:

#### CLASS I

- (a) For 35 to 69 trips per month in any direction—R0,10 per trip.  
(b) For 70 or more trips per month in any direction—R0,20 per trip.

In terms of section 9 (1) (a) of the National Roads Act, 1971 (Act No. 54 of 1971), the South African Roads Board, established in terms of section 2 of the South African Roads Board Act, 1988 (Act No. 74 of 1988), hereby declares that that portion of National Route 17, Section 1, as declared by Government Notice No. 2400 of 1989 titled "Regent's Park Extension 7-Elands Interchange" and that portion of National Route 3, Section 12, as declared by Proclamation No. 216 of 1982 titled "Old Barn Interchange-Gillooly's Interchange, consisting of that strip of surveyed Portion 421 (a portion of Portion 8) of Elandsfontein 108 JR where the said National Route 17, Section 1, joins National Route 3, Section 12, shall be a toll road. (Hendrik Schoeman Expressway Toll Road.)
