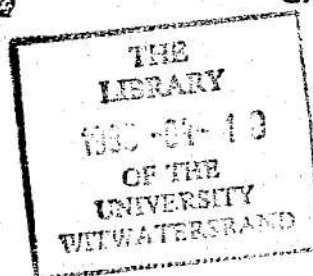

COUNCIL OF STATE AMENDMENT DECREE, 1990

COUNCIL OF STATE — REPUBLIC OF CISKEI

DECREE No 5 OF 1990

To provide for the Council of State to make laws by way of Decrees, and not by proclamations, and for that purpose to amend proclamations 1, 2, 6 and 7 of 1990, and to provide for matters incidental thereto.

BE IT PROCLAIMED AND DECREED by the Council of State of the Republic of Ciskei as follows:

1. Amendment of Proclamations 1 of 1990, 2 of 1990 and 6 of 1990 and 7 of 1990 -

(1) The State Council Proclamation, 1990 (Proclamation No. 1 of 1990), the Executive Government Proclamation, 1990 (Proclamation No. 2 of 1990), the State Trust Board Proclamation, 1990 (Proclamation No. 6 of 1990) and the Criminal Procedure Amendment Proclamation, 1990 (Proclamation No. 7 of 1990) are hereby amended by the substitution for the words "proclamation" or "proclamations" wherever they occur of the words "decree" or "decrees" as the case may be.

(2) It shall be deemed that the amendments contained in subsection (1) have come into operation at the same time that the respective proclamations came into operation.

2. Renumbering of Proclamation No. 6 of 1990 and No. 7 of 1990. - The State Trust Board Decree 1990, and the Criminal Procedure Amendment Decree, 1990, which were, prior to the coming into operation of this Decree numbered as proclamations No. 6 of 1990 and 7 of 1990 respectively are, hereby renumbered to be Decree No. 3 of 1990 and Decree No. 4 of 1990.

3. Amendment of Proclamations No. 1 of 1990 and 2 of 1990. - The State Council Decree, 1990 (formerly referred to as Proclamation No. 1 of 1990) and the Executive Government Decree, 1990 (formerly referred to as Proclamation No. 2 of 1990) are hereby amended by the substitution for the words "Chairman of the Executive Committee of the Council of State" wherever it occurs of the words "Chairman of the Council of State".

4. Amendment of Section 1 of Proclamation No. 1 of 1990. - Section 1 of the State Council Decree, 1990 (formerly referred to as Proclamation No. 1 of 1990) is hereby amended -

(a) by the deletion, in paragraph (i) of the word "President".

(b) by the addition after paragraph (i), of the following paragraphs:

"(j) That no court of law shall be competent to enquire into or to pronounce upon the validity of any Decree.

"(k) That the provisions of section 84(1) of the said Act shall be suspended."

5. Addition of section 7 to Proclamation No. 1 of 1990. - The State Council Decree, 1990 (formerly referred to as Proclamation No. 1 of 1990) is hereby amended by the addition of the following section:

"7. That this decree shall be called the State Council Decree, 1990."

6. Short title. - This decree shall be called the Council of State Amendment Decree, 1990. (Decree No. 5 of 1990).
