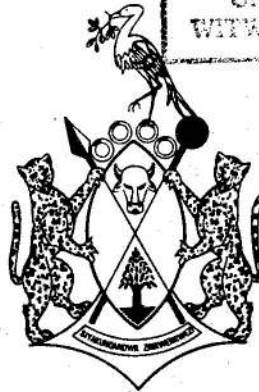

VALIDATION OF CERTAIN EXPENDITURE ACT, 1987, REPEAL DECREE, 1990

To repeal the Validation of Certain Expenditure Act, 1987.

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:

1. Repeal of Act No. 2 of 1987. - The Validation of Certain Expenditure Act, 1987 (Act No. 2 of 1987) is hereby repealed.
2. Short Title. - This Decree shall be called the Validation of Certain Expenditure Act, 1987 Repeal Decree, 1990 (Decree No. 7 of 1990).

ELITE UNIT REPEAL DECREE, 1990

To repeal the Elite Unit Act, 1986.

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:

1. Repeal of Act No. 18 of 1986. - (1) The Elite Unit Act, 1986 (Act No. 18 of 1986) is hereby repealed.
(2) The Elite Unit established under section 2 of that act is hereby disbanded, and its personnel transferred to the Ciskeian Police Force.
2. Short Title. - This Decree shall be called the Elite Unit Repeal Decree, 1990 (Decree No. 8 of 1990).
