To repeal the Validation of Certain Expenditure Act, 1987.

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:

- 1. Repeal of Act No. 2 of 1987. The Validation of Certain Expenditure Act, 1987 (Act No. 2 of 1987) is hereby repealed.
- 2. Short Title.-This Decree shall be called the Validation of Certain Expenditure Act, 1987 Repeal Decree, 1990 (Decree No. 7 of 1990).

ELITE UNIT REPEAL DECREE, 1990

To repeal the Elite Unit Act, 1986.

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:

- 1. Repeal of Act No. 18 of 1986. (1) The Elite Unit Act, 1986 (Act No. 18 of 1986) is hereby repealed.
- (2) The Elite Unit established under section 2 of that act is hereby disbanded, and its personnel transferred to the Ciskeian Police Force.
