


COUNCIL OF STATE — REPUBLIC OF CISKEI

INTERPRETATION AMENDMENT DECREE, 1990

DECREE No. 6 OF 1990

To amend the Interpretation Act, 1986, so as to provide for the interpretation of certain words during the period of Government by the Council of State, and to provide for matters incidental thereto.

BE IT DECREED by the Council of State for the Republic of Ciskei as follows:

1. Amendment of Section 2 of Act No. 19 of 1986. - Section 2 of the Interpretation Act, 1986 (Act No. 19 of 1986) is hereby amended:

(a) by the insertion after the definition of "Ciskei" of the following definitions:
"**Council of State**" means the Council which assumed control of the government and administration of the Republic of Ciskei on the fourth day of March 1990, and as from time to time constituted under the provisions of the Executive Government Decree, 1990 (Decree No. 2 of 1990).

"**Decree**" means a decree issued in terms of the Council of State Decree, 1990 (Decree No. 1 of 1990), as adapted by the Council of State Amendment Decree, 1990 (Decree No. 5 of 1990)."

(b) by the insertion of the the definition of "district" of the following definition:
"**Executive Council**" means the Council of State."

(c) by the substitution for the definition of "law" of the following definition:
"**law**" means any law, decree, proclamation, Act of the National Assembly or other enactment having the force of law."

(d) by the insertion after the definition of "law" of the following definition:
"**minister**" or "**minister of state**" shall mean a Councillor of State appointed under the provisions of the Executive Government Decree, 1990 (Decree No. 2 of 1990)."

(e) by the substitution for the definition of "national assembly" of the following definition:
"**national assembly**" or "**assembly**" means the Council of State."

(f) by the substitution for the definition of "President" of the following definition:
"**President**", "**President in Council**" or "**President in Executive Council**" means the Chairman of the Council of State, and includes any member of the Council of State who, in the absence or during the incapacity of the Chairman, is appointed by the remaining members of the Council of State to act as Chairman."

2. Council of State to be advised of certain matters - Any provision in any law which required any matter to be tabled in the national assembly to be advised of any matter within a certain period shall, unless the context otherwise indicates, be deemed to mean that the Council of State shall be advised of such matter in writing within such period.

3. Short title - This Decree shall be called the Interpretation Amendment Decree, 1990 (Decree No. 6 of 1990).
