**WET**

Tot wysiging van die Wet op die Besoldiging van Stadsklerke, 1984, ten einde voorsiening te maak vir die aanstelling van komitees en die delegering van werkzaamhede deur die Raad op Besoldiging en Diensvoordele van Stadsklerke; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

**D**AAR WORD BEPAAL deur die Staatspresident en die Parlement van die Republiek van Suid-Afrika, soos volg:—

**Invoeging van artikels 6B en 6C in Wet 115 van 1984**

1. Die volgende artikels word hierby in die Wet op die Besoldiging van Stadsklerke, 1984, na artikel 6A ingevoeg:

**"Komitees**

**6B.** (1) Die raad kan, indien hy dit nodig of dienstig ag vir die behoorlike uitoefening of verrigting van enige bevoegdheid, plig of werkzaamheid wat by of kragtens hierdie Wet aan hom verleen of opgedra is, uit sy geledere of andersins een of meer komitees aanstel, 'n voorsitter vir so 'n komitee aanwys en die werkzaamhede van die komitee bepaal.

(2) 'n Meerderheid van die totale getal lede van 'n komitee in subartikel (1) bedoel, maak 'n kworum uit.

(3) 'n Komitee in subartikel (1) bedoel, vergader so dikwels as wat nodig is vir die afhandeling van sy werkzaamhede.

(4) Wanneer die voorsitter van 'n komitee in subartikel (1) bedoel om enige rede afwesig is of nie in staat is om as voorsitter van 'n vergadering op te tree nie, kies die teenwoordige lede uit hul gelêdere iemand om as voorsitter waar te neem.

(5) Ondanks die bepalings van artikel 6 bepaal die raad die wyse waarop 'n komitee in subartikel (1) bedoel, kan stem.

**Delegering**

**6C.** Die raad kan skriftelik enige bevoegdheid of plig by of kragtens hierdie Wet aan hom verleen of opgedra, hetby in die algemeen of in 'n bepaalde geval of in gevalle van 'n bepaalde aard aan 'n komitee in artikel 6B (1) bedoel of aan die sekretaris ingevolge artikel 2 (2) aangewys, deleger of opdra op die voorwaardes wat hy goedvind.”.

## REMUNERATION OF TOWN CLERKS AMENDMENT ACT, 1990

Act No. 26, 1990

## GENERAL EXPLANATORY NOTE:

## ACT

To amend the Remuneration of Town Clerks Act, 1984, to provide for the appointment of committees and the delegation of functions by the Board on Remuneration and Service Benefits of Town Clerks; and to provide for matters connected therewith.

(Assented to 23 March 1990.)

BE IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

## Insertion of sections 6B and 6C in Act 115 of 1984

1. The following sections are hereby inserted after section 6A of the Remuneration of Town Clerks Act, 1984:

“Committees

6B. (1) The board may, if it deems it necessary or expedient for the proper exercise or performance of any power, duty or function conferred or imposed upon the board by or under this Act, from its members or otherwise appoint one or more committees, designate a chairman for such a committee and determine the functions of the committee.

(2) A majority of the total number of members of a committee contemplated in subsection (1), shall constitute a quorum.

(3) A committee contemplated in subsection (1) shall meet as often as may be necessary for the performance of its functions.

(4) Whenever the chairman of a committee referred to in subsection (1) is for any reason absent or unable to act as chairman at a meeting, the members present shall from among their number elect a person to act as chairman.

(5) Notwithstanding the provisions of section 6 the board shall determine the manner in which a committee contemplated in subsection (1) may vote.

Delegation

6C. The board may in writing and on such conditions as it may deem fit delegate or assign, either in general or in a particular case or in cases of a particular nature, any power or duty conferred upon or assigned to it by or under this Act, to a committee referred to in section 6B (1) or to the secretary designated in terms of section 2 (2).”

Short title

30 2. This Act shall be called the Remuneration of Town Clerks Amendment Act, 1990.
