WYSIGING VAN VOORWAARDES INGEVOLGE ARTIKEL 162 VAN DIE WATERWET, 1956 (WET No. 54 VAN 1956), VIR DIE TOEKENNING VAN SUBSIDIES AAN PLAASLIKE OWERHEDE, WATERRADE EN STREEKWATERDIENSTE-KORPORASIES TEN OPSIGTE VAN DIE KOSTE VERBONDE AAN DIE AANBOU EN OPGRAДЕRING VAN WATERVOORSIENINGSWERKE

1. Die Minister van Waterwese het kragtens die bevoegdheid hom verleen by artikel 162 van die Waterwet, 1956 (Wet No. 54 van 1956), goedkeur dat Goewermentskennisgewing No. 1341 van 30 Junie 1989, gewysig word deur—

(a) die skrapping van die uitdrukking "Graad 6 45 c/m<sup>3</sup>." en "Graad 7 50 c/m<sup>3</sup>." waar dit in paragraaf 2.11 voorkom;

(b) die vervanging van paragrawe 3 tot en met 3.2 deur die volgende:

"3. Waterrade (slegs dié wat daargestel is vir die voorsiening van water hoofsaaklik vir huis-houdelike en veesuijingsdoeleindes):

3.1 'n Waterraad soos hierbo vermeld wat die toekenning van 'n subsidie op 'n beoogde waterwerk verlang, moet skriftelik by die Direkteur-generaal daarom aansoek doen.

3.2 Die bepalings van paragrawe 2.1 tot 2.22 is *mutatis mutandis* van toepassing op sodanige waterrade: Met dien verstande dat—

(i) die kwalifiserende eenheidsprys 50c per kubieke meter is; en

(ii) Die subsidie nie 33½% van die subsidieerbare koste oorskry nie"; en

(c) die skrapping van paragrawe 4 tot en met 4.2.

AMENDMENT OF CONDITIONS IN TERMS OF SECTION 162 OF THE WATER ACT, 1956 (ACT No. 54 OF 1956), FOR THE GRANTING OF SUBSIDIES TO LOCAL AUTHORITIES, WATER BOARDS AND REGIONAL WATER SERVICES CORPORATIONS IN RESPECT OF THE COSTS RELATED TO THE CONSTRUCTION AND UPGRADING OF WATER SUPPLY WORKS

1. The Minister of Water Affairs has, by virtue of the powers vested in him by section 162 of the Water Act, 1956 (Act No. 54 of 1956), approved that Government Notice No. 1341 of 30 June 1989, be amended by—

(a) the deletion of the expressions "Grade 6 45 c/m<sup>3</sup>." and "Grade 7 50 c/m<sup>3</sup>." where they occur in paragraph 2.11;

(b) substituting the following paragraphs for paragraphs 3 up to and including 3.2:

"3. Water boards (only those established for the provision of water mainly for domestic and stock watering purposes):

3.1 A water board as contemplated above that desires the granting of a subsidy on an envisaged water work must apply for it in writing to the Director-General.

3.2 the provisions of paragraphs 2.1 to 2.22 shall apply *mutatis mutandis* to such water boards: Provided that—

(i) the qualifying unit price shall be 50c per cubic metre; and

(ii) the subsidy shall not exceed 33½% of the subsidisable costs."; and

(c) the deletion of paragraphs 4 up to and including 4.2.

2. Bostaande wysiging van Goewermentskennisgewing No. 1341 van 30 Junie 1989 beïnvloed nie die uitbetaling aan plaaslike owerhede, waterrade en streekwaterdienstekorporasies wat water vir stedelike en nywerheidsdoeleindes verskaf, van subsidies wat voor 23 Maart 1990 deur die Direkteur-generaal: Waterwese goedgekeur is nie en ook nie die betaling van subsidies aan sulke instansies aan wie 'n skriftekoonderneming voor gemelde datum gegee is om 'n watervoorsieningskema aan die hand van gemelde Goewermentskennisgewing te subsidieer nie. In sodanige gevalle geld die bepalings van gemelde Goewermentskennisgewing dus asof dit nie gewysig is nie, tot tyd en wyl sodanige subsidies uitgefaseer is.

**WYSIGING VAN VOORWAARDES INGEVOLGE ARTIKEL 162 VAN DIE WATERWET, 1956 (WET NO. 54 VAN 1956), VIR DIE TOEKENNING VAN SUBSIDIES AAN PLAASLIKE OWERHEDEN TEN OPSIGTE VAN DIE KOSTE VERBONDE AAN DIE AANBOU EN VERBETERING VAN RIOOLWATERBEHANDELINGSWERKE EN RIOOLNETWERKSTELSELS**

1. Die Minister van Waterwese het kragtens die bevoegdheid hom verleen by artikel 162 van die Waterwet, 1956 (Wet No. 54 van 1956), goedgekeur dat Goewermentskennisgewing No. 247 van 6 Februarie 1987 gewysig word deur—

- (a) die vervanging van die uitdrukking "plaaslike besture" deur die uitdrukking "plaaslike owerhede" waar dit ook al in genoemde kennisgewing voorkom;
- (b) die skrapping van paragraaf 2.3; en
- (c) die skrapping van die uitdrukking "Graad 6 en Graad 7 plaaslike besture: 25 c/m<sup>3</sup>." waar dit in paragraaf 11 voorkom.

2. Bostaande wysiging van Goewermentskennisgewing No. 247 van 6 Februarie 1987 beïnvloed nie die uitbetaling aan plaaslike besture van subsidies wat voor 23 Maart 1990 reeds deur die Direkteur-generaal: Waterwese goedgekeur is nie en ook nie die betaling van subsidies aan 'n Graad 6 en Graad 7 plaaslike owerheid aan wie 'n skriftelike onderneming voor gemelde datum gegee is om 'n riuolbehandelingswerk aan die hand van gemelde Goewermentskennisgewing te subsidieer nie. In sodanige gevalle geld die bepalings van gemelde Goewermentskennisgewing dus asof dit nie gewysig is nie, tot tyd en wyl sodanige subsidies uitgefaseer is.

3. Hierdie kennisgewing vervang Goewermentskennisgewing No. 579 van 23 Maart 1990.

2. The above amendment to Government Notice No. 1341 of 30 June 1989 shall have no bearing on the payment to local authorities, water boards and regional water services corporations that supply water for urban and industrial purposes of subsidies that had been approved before 23 March 1990 by the Director-General: Water Affairs nor on the payment of subsidies to such bodies to which a written undertaking had been given before the said date to subsidise a water supply scheme in terms of the said Government Notice. In such cases the provisions of the said Government Notice therefore apply as though it had not been amended, until such time as such subsidies are phased out.

3. This notice supersedes Government Notice No. 580 of 23 March 1990.

**AMENDMENT OF CONDITIONS IN TERMS OF SECTION 162 OF THE WATER ACT, 1956 (ACT NO. 54 OF 1956), FOR THE GRANT OF SUBSIDIES TO LOCAL AUTHORITIES ON THE COST OF CONSTRUCTING AND IMPROVING SEWAGE TREATMENT WORKS AND SEWAGE RETICULATION SYSTEMS**

1. The Minister of Water Affairs has, by virtue of the powers vested in him by section 162 of the Water Act, 1956 (Act No. 54 of 1956), approved that Government Notice No. 247 of 6 February 1987, be amended by—

- (a) substituting in the Afrikaans text, the expression "plaaslike besture" for the expression "plaaslike owerhede" where it occurs in the said notice;
- (b) the deletion of paragraph 2.3; and
- (c) the deletion of the expression "Grade 6 and Grade 7 local authorities: 25 c/m<sup>3</sup>." where it occurs in paragraph 11.

2. The above amendment to Government Notice No. 247 of 6 February 1987 shall have no bearing on the payment to local authorities of subsidies that had been approved before 23 March 1990 by the Director-General: Water Affairs nor on the payment of subsidies to a Grade 6 and Grade 7 local authority to which a written undertaking had been given before the said date to subsidise a sewage treatment work in terms of the said Government Notice. In such cases the provisions of the said Government Notice therefore apply as though it had not been amended, until such time as such subsidies are phased out.

3. This notice supersedes Government Notice No. 579 of 23 March 1990.
