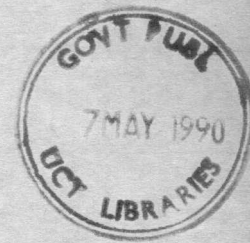

ROAD TRAFFIC ACT, 1989 (ACT No. 29

COMMENCEMENT OF CERTAIN
SECTIONS

By virtue of the powers vested in me by section 154 of the Road Traffic Act, 1989 (Act No. 29 of 1989), I hereby fix the date 1 June 1990 as the date on which all the sections, except sections 1 (xLvi), (Liv), (Lv), (Lxv), (Lxvi) and (Lxxi), 3 (2), 4-6, 20-21, 22 (2) and (3), 33-37, 41-60, 61 (2) and (3), 62 (2), (3), (4) and (5), 63-69, 71, 74-81 and 87 of the said Act come into operation.
