**50c:** 22 mm met 'n positiewe en negatiewe toleransie van 0,08 mm;

**20c:** 19 mm met 'n positiewe en negatiewe toleransie van 0,08 mm;

**10c:** 16 mm met 'n positiewe en negatiewe toleransie van 0,08 mm;

**2c:** 18 mm met 'n positiewe en negatiewe toleransie van 0,08 mm;

**1c:** 15 mm met 'n positiewe en negatiewe toleransie van 0,08 mm.

SOUTH AFRICAN RESERVE BANK ACT, 1989

**THE DIMENSIONS OF, DESIGNS FOR, AND COMPILATION OF THE FOLLOWING COINS: R1 (existing series), R1 (new series), 50c, 20c, 10c, 2c and 1c**

By virtue of the powers vested in me by section 19 (1) (a) of the South African Reserve Bank Act (Act No. 90 of 1989), I hereby declare—

- (a) that the R1 (existing series), R1 (new series), 50c, 20c, 10c, 2c and 1c coins of the Republic of South Africa, as set out in section (b) of the Second Schedule to the said Act, and which is being manufactured and which will be issued by virtue of section 16 (1) of the said Act, shall be legal tender as from 1 May 1990; and
- (b) that the diameters and the designs of the said coins shall be the diameters and designs as is shown in Schedule A which is attached to this notice; and
- (c) that the diameters of the said coins are as follows:

**R1 (existing series):** 31 mm with a positive and negative tolerance of 0,08 mm;

**R1 (new series):** 20 mm with a positive and negative tolerance of 0,08 mm;

**50c:** 22 mm with a positive and negative tolerance of 0,08 mm;

**20c:** 19 mm with a positive and negative tolerance of 0,08 mm;

**10c:** 16 mm with a positive and negative tolerance of 0,08 mm;

**2c:** 18 mm with a positive and negative tolerance of 0,08 mm;

**1c:** 15 mm with a positive and negative tolerance of 0,08 mm.


