NOTICE OF THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA

NOTICE OF TEMPORARY IMMUNITY UNDER
THE INDEMNITY ACT, 1990 (ACT No. 35 OF
1990)

Whereas I, Frederik Willem de Klerk, State Presi-
dent of the Republic of South Africa, am of the opinion
that it is necessary for the promotion of peaceful consti-
tutional solutions in South Africa, I hereby under the
power vested in me by section 1 (1) of the Indemnity
Act, 1990 (Act No. 35 of 1990), unconditionally grant
to Nakedi Mathews Phosa, immunity referred to in
section 1 (2) of the aforementioned Act for the period 8
June 1990 to and including 19 August 1990.

of South Africa at Cape Town this Seventh day of June,
One thousand Nine hundred and Ninety.
