AREA OF NATIONAL SORGHUM BREWERIES,

Under section 1 (2) of the Sorghum Beer Act, 1962 (Act No. 63 of 1962), I, Hermanus Jacobus Kriel, Minister of Planning and Provincial Affairs, hereby define the urban area of the National Sorghum Breweries, Limited as follows:

The Republic, but not any area declared under section 26 of the National States Constitution Act, 1971 (Act No. 21 of 1971), to be a self-governing territory and any Black area referred to in the Sorghum Beer Act, 1962, in so far as any such Black area has not been included in any such self-governing territory.

WITHDRAWAL OF THE EXCLUSIVE RIGHT OF  
SUPPLY OF SORGHUM BEER

Under section 7 of the Sorghum Beer Act, 1962 (Act No. 63 of 1962), I, Hermanus Jacobus Kriel, Minister of Planning and Provincial Affairs, hereby withdraw, as from 1 July 1990 and in respect of the whole of its urban area, the exclusive right which any local authority has under section 6 of the said Act to manufacture, sell and deliver sorghum beer.
