WET

Om voorsiening te maak vir die uitbreiding van die toepassing van sekere bepalings van die Ordonnansie op Openbare Oorde, 1969 (Transvaal) (vir sover dit as 'n wet oor eie sake van die Blanke bevolkingsgroep toegepas word), na die provinsies die Oranje-Vrystaat en die Kaap die Goeie Hoop; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Staatspresident en die Volksraad van die Republiek van Suid-Afrika, soos volg:—

Woordomskrywing

1. In hierdie Wet, tensy uit die samehang anders blyk, beteken—
 - (i) "Minister" die Minister van Begroting en Plaaslike Bestuur: Volksraad; (ii) 5
 - (ii) "Ordonnansie op Openbare Oorde, 1969 (Transvaal)", die bepalings van die Ordonnansie op Openbare Oorde, 1969 (Ordonnansie No. 18 van 1969) (Transvaal), bedoel in artikel 2; (iii) en
 - (iii) "Raad" die Raad vir Openbare Oorde bedoel in artikel 5 van die Ordonnansie op Openbare Oorde, 1969 (Ordonnansie No. 18 van 1969) 10 (Transvaal), soos gewysig by Proklamasie No. 180 van 1988. (i)

Uitbreiding van toepassing van Ordonnansie op Openbare Oorde, 1969 (Transvaal)

2. Behoudens die bepalings van hierdie Wet word die bepalings van die Ordonnansie op Openbare Oorde, 1969 (Ordonnansie No. 18 van 1969) (Transvaal), vir sover en in die mate waarin die bepalings van Deel IV van die Grondwet van die 15 Republiek van Suid-Afrika, 1983 (Wet No. 110 van 1983), kragtens paragraaf (a) (i) en (ii) van Proklamasie No. 180 van 1988 op genoemde Ordonnansie van toepassing verklaar is, en soos by genoemde Proklamasie en by artikel 5 van hierdie Wet gewysig, hierby van toepassing verklaar in die provinsies die Oranje-Vrystaat en die Kaap die Goeie Hoop vir sover en in die mate waarin die bepalings van genoemde 20 Deel IV van die Grondwet van die Republiek van Suid-Afrika, 1983, by onderskeidelik paragraaf (a) (i) en (ii) van Proklamasie No. 173 van 1989 en paragraaf (a) (i) en (ii) van Proklamasie No. 174 van 1989, met betrekking tot die Blanke bevolkingsgroep en die oorde in die onderskeie paragrawe vermeld, in die onderskeie 25 provinsies van toepassing verklaar is.

Agtings- en magtigende bepalings

3. By die toepassing van die Ordonnansie op Openbare Oorde, 1969 (Transvaal), ooreenkomstig artikel 2, en met ingang van die datum van inwerkingtreding van hierdie Wet—

- (a) word die oorde Willem Pretorius, Hendrik Verwoerd, Jim Fouché en 30 Maselspoort en die oord Keurboomsvier vermeld in onderskeidelik paragraaf (a) (ii) van Proklamasie No. 173 van 1989 en paragraaf (a) (ii)

EXTENSION OF THE PUBLIC RESORTS ORDINANCE ACT
(TRANSVAAL) (HOUSE OF ASSEMBLY), 1990

Act No. 105, 1990

ACT

To provide for the extension of the application of certain provisions of the Public Resorts Ordinance, 1969 (Transvaal) (in so far as it is applied as a law on own affairs of the White population group), to the provinces of the Orange Free State and the Cape of Good Hope; and to provide for matters connected therewith.

*(Afrikaans text signed by the State President.)
(Assented to 28 June 1990.)*

BE IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

Definitions

1. In this Act, unless the context otherwise indicates—
- 5 (i) "Board" means the Board for Public Resorts referred to in section 5 of the Public Resorts Ordinance, 1969 (Ordinance No. 18 of 1969) (Transvaal), as amended by Proclamation No. 180 of 1988; (iii)
- (ii) "Minister" means the Minister of the Budget and Local Government; House of Assembly; (i) and
- 10 (iii) "Public Resorts Ordinance, 1969 (Transvaal)", means the provisions of the Public Resorts Ordinance, 1969 (Ordinance No. 18 of 1969) (Transvaal), referred to in section 2. (ii)

Extension of application of Public Resorts Ordinance, 1969 (Transvaal)

2. Subject to the provisions of this Act, the provisions of the Public Resorts Ordinance, 1969 (Ordinance No. 18 of 1969) (Transvaal), in so far as and to the extent to which the provisions of Part IV of the Republic of South Africa Constitution Act, 1983 (Act No. 110 of 1983), have under paragraph (a) (i) and (ii) of Proclamation No. 180 of 1988 been declared to be applicable to the said Ordinance, and as amended by the said Proclamation and section 5 of this Act, are
- 20 hereby declared applicable in the provinces of the Orange Free State and the Cape of Good Hope in so far as and to the extent to which the provisions of the said Part IV of the Republic of South Africa Constitution Act, 1983, have by paragraph (a) (i) and (ii) of Proclamation No. 173 of 1989 and paragraph (a) (i) and (ii) of Proclamation No. 174 of 1989, respectively, been declared to be applicable in the
- 25 respective provinces, in relation to the White population group and the resorts mentioned in the respective paragraphs.

Deeming and enabling provisions

3. In the application of the Public Resorts Ordinance, 1969 (Transvaal), in accordance with section 2, and from the date of commencement of this Act—
- 30 (a) the resorts Willem Pretorius, Hendrik Verwoerd, Jim Fouché and Maselspoort and the resort Keurboomsrivier mentioned in paragraph (a) (ii) of Proclamation No. 173 of 1989 and paragraph (a) (ii) of Proclamation No.

van Proklamasie No. 174 van 1989 geag kragtens artikel 3 (2) (a) van genoemde Ordonnansie as openbare oorde ingestel te wees;

(b) word Bylae 1 by genoemde Ordonnansie geag ooreenkomstig Bylae 1 by hierdie Wet kragtens artikel 3 (3) (a) van daardie Ordonnansie gewysig te wees; en

(c) kan die Minister, die Raad en enige ander persoon in die provinsie die Oranje-Vrystaat en die provinsie die Kaap die Goeie Hoop enige handeling verrig wat deur die Minister, die Raad of so 'n ander persoon kragtens genoemde Ordonnansie in die provinsie Transvaal verrig kan word.

Oorplasing van personeel

4. (1) 'n Persoon in die staatsdiens ingevolge die Staatsdienswet, 1984 (Wet No. 111 van 1984), en wat onmiddellik voor die inwerkingtreding van hierdie Wet by die Administrasie: Volksraad in diens was, kan met sy instemming deur die Minister na die diens van die Raad oorgeplaas word en word by sodanige oorplasing geag kragtens artikel 24 (2) van die Ordonnansie op Openbare Oorde, 1969 (Transvaal), deur die Raad aangestel te wees.

(2) Die diensvoorwaardes waaronder 'n persoon bedoel in paragraaf (a) onmiddellik voor sy aldus bedoelde oorplasing diens gelewer het, word by sodanige oorplasing nie tot sy nadeel geraak nie, en geen diensvoorwaarde wat op hom betrekking het, word na sodanige oorplasing uitgelê of toegepas op 'n wyse wat minder gunstig vir hom is as die wyse waarop dit onmiddellik voor sodanige oorplasing uitgelê of toegepas is nie.

Wysiging of herroeping van wette, en oorgangsbepalings

5. (1) Behoudens die bepalinge van subartikels (2) en (3) word die wette in Bylae 2 vermeld hierby gewysig of herroep in die mate in die derde kolom daarvan aangedui.

(2) Diensvoorwaardes beoog in artikel 24 (2) van die Ordonnansie op Openbare Oorde, 1969 (Transvaal), wat onmiddellik voor die datum van die inwerkingtreding van hierdie Wet kragtens daardie artikel as regulasies gegeld het, hou op daardie datum op om aldus as regulasies te geld, en word vanaf daardie datum geag kragtens daardie artikel soos by subartikel (1) gewysig, deur die Raad bepaal te wees.

(3) Enigiets wat ingevolge die bepalinge van die Ordonnansie op Openbare Oorde, 1971 (Ordonnansie No. 20 van 1971) (Kaap die Goeie Hoop), of uit hoofde van artikel 11 (2) van die Wet op Finansiële Verhoudings, 1976 (Wet No. 65 van 1976), soos by subartikel (1) herroep, gedoen is en wat ingevolge 'n bepaling van die Ordonnansie op Openbare Oorde, 1969 (Transvaal), gedoen kan word, word, tensy dit klaarblyklik onvanpas is, geag onderskeidelik ingevolge die ooreenstemmende bepaling, of uit hoofde, van laasgenoemde Ordonnansie gedoen te wees.

Kort titel en inwerkingtreding

6. Hierdie Wet heet die Wet op die Uitbreiding van die Ordonnansie op Openbare Oorde (Transvaal) (Volksraad), 1990, en tree in werking op 'n datum wat die Staatspresident by proklamasie in die *Staatskoerant* bepaal.

- 174 of 1989, respectively, shall be deemed to have been established as public resorts under section 3 (2) (a) of the said Ordinance;
- (b) Schedule 1 to the said Ordinance shall be deemed to have been amended under section 3 (3) (a) of that Ordinance in accordance with Schedule 1 to this Act; and
- (c) the Minister, the Board and any other person may perform any act in the province of the Orange Free State and the province of the Cape of Good Hope which may be performed by the Minister, the Board or such other person under the said Ordinance in the province of the Transvaal.

10 Transfer of staff

4. (1) Any person in the public service in terms of the Public Service Act, 1984 (Act No. 111 of 1984), and who immediately prior to the commencement of this Act was in the employment of the Administration: House of Assembly, may, with his approval, be transferred by the Minister to the service of the Board and shall on such transfer be deemed to have been appointed by the Board under section 24 (2) of the Public Resorts Ordinance, 1969 (Transvaal).

- (2) The conditions of service subject to which any person referred to in paragraph (a) was serving immediately prior to his transfer so referred to, shall on such transfer not be affected to his detriment and no condition of service relating to him shall after such transfer be construed or applied in any manner that is less favourable to him than the manner in which it was construed or applied immediately prior to such transfer.

Amendment or repeal of laws, and transitional provisions

5. (1) Subject to the provisions of subsections (2) and (3), the laws mentioned in Schedule 2 are hereby amended or repealed to the extent set out in the third column thereof.

- (2) Conditions of service contemplated in section 24 (2) of the Public Resorts Ordinance, 1969 (Transvaal), which applied immediately prior to the date of commencement of this Act as regulations under that section, shall on that date cease so to apply as regulations, and shall from that date be deemed to have been determined by the Board under that section as amended by subsection (1).

- (3) Anything done in terms of the provisions of the Public Resorts Ordinance, 1971 (Ordinance No. 20 of 1971) (Cape of Good Hope), or by virtue of section 11 (2) of the Financial Relations Act, 1976 (Act No. 65 of 1976), as repealed by subsection (1) and which may be done in terms of any provision of the Public Resorts Ordinance, 1969 (Transvaal), shall, unless clearly inappropriate, be deemed to have been done in terms of the corresponding provision, or by virtue, of the last-mentioned Ordinance, respectively.

Short title and commencement

6. This Act shall be called the Extension of the Public Resorts Ordinance Act (Transvaal) (House of Assembly), 1990, and shall come into operation on a date fixed by the State President by proclamation in the *Gazette*.
