#### NOTICE OF THE STATE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA

#### NOTICE OF TEMPORARY IMMUNITY UNDER THE INDEMNITY ACT, 1990 (ACT NO. 35 OF 1990)

Whereas I am of the opinion that it is necessary for the promotion of peaceful constitutional solutions in South Africa, I hereby under the power vested in me by section 1 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), unconditionally grant to the persons specified in the Schedule, immunity referred to in section 1 (2) of the aforementioned Act for the period from 20 August 1990 to and including 31 December 1990.

Given under my Hand and the Seal of the Republic of South Africa at Pretoria this Sixteenth day of August, One thousand Nine hundred and Ninety.
