

(b) bepaal hierby, vir die doeleindes van artikel 45 (1) van genoemde Wet, 'n koers van 20 persent per jaar,

(b) hereby fix, for the purposes of section 45 (1) of the said Act, a rate of 20 per cent per annum,

vir die berekening van rente.
