ARMS AND AMMUNITION ACT, 1969  
(ACT No. 75 OF 1969)

INDEMNITY IN TERMS OF SECTION 4 (1) OF THE  
ARMS AND AMMUNITION ACT

By virtue of the powers vested in me by section 4 (1) of the Arms and Ammunition Act, 1969 (Act No. 75 of 1969), I, Gert Benjamin Myburgh, Deputy Minister of Law and Order, acting on behalf of and on assignment by the Minister of Law and Order, provide that any person who is in possession of any arm or ammunition contrary to the provisions of section 2 or 36, and who surrenders such arm or ammunition to a member of the South African Police on duty at a police station within 90 days after the commencement of this notice shall not be prosecuted for a contravention of the said sections.
