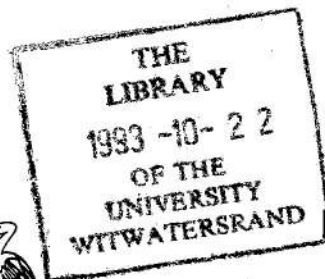
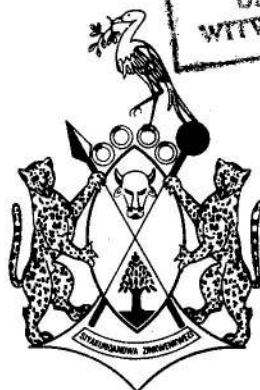

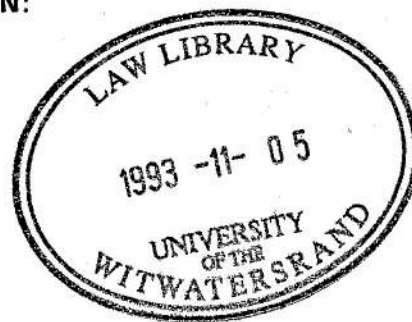

## INDEMNITY AMENDMENT DECREE, 1993

### DECREE

To amend the Special Indemnity Decree, 1993.

*[English text signed by the Chairman of the Council of State. Assented to on 28 July 1993].*

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

**1. Amendment of Section 1 of Decree No. 7 of 1993.** - Section 1 of the Special Indemnity Decree, 1993 is hereby amended by the substitution for the definition of "Act" of the following definition:

"'Act' means any act of a combatant or military nature or causing damage to property (whether real or apparent) advised, commanded, directed, ordered or performed -

- (a) by any member of the Ciskeian Security Forces, in the interests of National Security, territorial integrity or public safety or for the prevention of disorder or crime, in or in connection with the encounter between the said Forces and certain demonstrators on 7 September 1992 at or near Bisho in the district of Zwelitsha; and
- (b) by the said demonstrators and their assistants generally in disregard or defiance of or pretended compliance with a permit, permission or other authorization for the holding on the said date at or in a specified place at or in the aforesaid locality, of a meeting, gathering, demonstration or assembly;"

**2. Short title.** - This decree shall be called the Indemnity Amendment Decree, 1993.
