UNEMPLOYMENT INSURANCE ACT, 1966

INCREASE OF THE RATES AT WHICH EMPLOYERS AND CONTRIBUTORS ARE REQUIRED TO CONTRIBUTE TO THE UNEMPLOYMENT INSURANCE FUND

I, Leon Wessels, Minister of Manpower, acting under the powers vested in me by section 45 (2) of the Unemployment Insurance Act, 1966 (Act No. 30 of 1966), amend hereby with effect from **1 October 1993** the rate of 0,9 per cent and 0,9 per cent of the earnings of the contributor, at which employers and contributors, respectively, are in terms of section 29 (1) of the said Act required to contribute to the Unemployment Insurance Fund, by increasing it in the case of both such employers and such contributors to 1,0 per cent of the earnings of the contributor.

UNEMPLOYMENT INSURANCE ACT, 1966

EXTENSION OF THE PERIOD OF EXEMPTION GRANTED TO EMPLOYERS IN AGRICULTURE IN TERMS OF SECTION 17 (1) OF THE UNEMPLOYMENT INSURANCE AMENDMENT ACT, 1992 (ACT NO. 130 OF 1992)

1. Representations have been received that the period of grace of nine months, during which employers in agriculture must register with the Unemployment Insurance Fund, should be extended. To give the Unemployment Insurance Board the opportunity to consider the matter, and advise me accordingly, a temporary extension of the period of grace is required.
