

It is hereby notified that the Chairman of the Council of State has assented to the following decree which is hereby published for general information:-

TOWNSHIPS AMENDMENT DECREE, 1993

DECREE

To amend Proclamation R.293 of 1962.

[English text signed by the Chairman of the Council of State. Assented to on 24 August 1993.]

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

- 1. Interpretation. In this decree "the Proclamation" means Proclamation R.293 of 1962, as amended by Proclamation R.211 of 1969, R.162 of 1970, R.222 of 1971, R.150 of 1976, R.34 of 1977, R.178 of 1978, R.200 of 1978 and R.197 of 1979, by section 5 of Act 29 of 1983 and by Decrees 44 of 1990 and 10 of 1991.
- 2. Amendment of regulation 23 of Chapter 2 of the Proclamation. Regulation 23 of Chapter 2 of the Proclamation is hereby amended -
 - (a) by the insertion in subregulation (2) of the following paragraph:
 - (c) on the grantee failing to pay any sum for which he is liable in terms of this Chapter within two months of the date on which such sum became due and payable;";
 - (b) by the addition to subregulation (2) of the following paragraph:
 - "(e) if the grantee abandons the site or fails to use it for the purpose for which it was granted to him for a period in excess of twelve months after the date of the grant or after the date on which he entered into occupation of the site (whichever is the later) unless he shall first have obtained permission in writing from the town clerk to absent himself from the township over that period."; and
 - (c) by the substitution in subregulation (3) for the expression "Cancellation of a deed of grant in terms of subregulation (1) or (2)" of the expression "Cancellation of a deed of grant in terms of subregulation (1) or (2) otherwise than by order of the Minister".
- Short title and commencement. This decree shall be called the Townships Amendment Decree, 1993 and shall be deemed to have come into operation on 28 December 1990.
