MAGALIES TOLL ROAD: PUBLICATION OF THE AMOUNTS OF TOLL FOR THE VARIOUS CATEGORIES OF MOTOR VEHICLES, THE TIMES AT WHICH THE TOLL ROAD MAY BE USED AND THE DATE UPON AND TIME AT WHICH THE TOLL TARIFFS SHALL BECOME PAYABLE

The South African Roads Board hereby, in terms of section 9 (4) (c) of the National Roads Act, 1971 (Act No. 54 of 1971), as amended, makes known that the amounts of toll which it may levy in terms of section 9 (1) (b) of the said Act at the Pelindaba Toll Plaza on the toll road declared under Government Notice No. 2223 of 1990, and the date and time at which the amounts of toll shall become payable, have been altered by the Minister of Transport and of Posts and Telecommunications in terms of section 9 (4) (a) and 9 (4) (d) thereof and that the said amounts shall be levied in terms of section 9 (4) (b) (ii) and (iii) thereof, as set out in the Schedule hereto.

BYLAE

1. WOORDOMSKRYWING

- 1.1 "Motorvoertuig" beteken 'n geheel bestaande uit een of meer meganies aangedrewe eenhede met of sonder sleepwa of sleepwaens wat fisies aan mekaar gekoppel is deur middel van sleepstange, sleepstoe of meganiese geleiding en ook—
(a) 'n motorfiets;
(b) 'n motordriewiel;
(c) 'n motorkar;

- (d) a vehicle which has pedals and a mechanically powered unit as an integral part thereof or attached thereto and which is designed or adapted to be propelled by means of either such pedals or such mechanical unit or both; and
- (e) a light delivery vehicle (a bakkie).
- 1.2 "**Motor cycle**" means a motor vehicle which has two wheels and includes any such vehicle having a side-car attached thereto.
- 1.3 "**Motor tricycle**" means a motor vehicle, other than a motor cycle with a side-car, which has three wheels and which is designed to be driven by means of the type of controls usually fitted to a motor cycle.
- 1.4 "**Motor car**" means a motor vehicle, other than a motor cycle or a motor tricycle, designed or adapted solely or principally for the conveyance of persons not exceeding sixteen (16) in number.
- 1.5 "**Light delivery vehicle**" means a motor vehicle designed or adapted for the conveyance of persons and freight with a tare not exceeding one comma five (1,5) ton and with no heavy axle as defined in paragraph 1.7 hereunder.
- 1.6 "**Axle**" means a device or set of devices, whether continuous across the width of the vehicle or not, about which the wheels of the vehicle rotate and which is so placed that, when the vehicle is travelling straight ahead, the vertical centre-lines of such wheels are in one vertical plane at right angles to the longitudinal centre-line of such vehicle.
- 1.7 "**Heavy axle**" means an axle the wheels of which are fitted with tyres of a size (bead seat diameter) greater than 406,4 millimetres (16 inches), or an axle with more than two (2) wheels irrespective of tyre size but excluding any axle of a motor cycle, a motor tricycle or a motor car.
- 1.8 "**Light vehicle**" means a motor vehicle, other than heavy vehicles as defined hereunder.
- 1.9 "**Heavy vehicle**" means a motor vehicle with at least one heavy axle.
- 1.10 "**Abnormal vehicle**" means a motor vehicle exceeding the legal dimensions as described in the Road Traffic Act, 1989, or in any other law.
- 1.11 "**Trailer**" means a vehicle which is not self-propelled and which is designed or adapted to be drawn by a motor vehicle but does not include a side-car attached to a motor cycle.
- (d) 'n voertuig met pedale en met 'n meganiese aangedrewe eenheid as 'n integreerende deel daarvan of daarvan vasgeheg en wat ontwerp of aangepas is om óf deur middel van sodanige pedale of deur middel van die mekaniese eenheid óf deur albei voortbeweeg te word; en
- (e) 'n ligte afleveringsvoertuig ('n bakkie).
- 1.2 "**Motorfiets**" beteken 'n motorvoertuig met twee wiele en ook enige sodanige voertuig waaraan 'n syspan geheg is.
- 1.3 "**Motordriewiel**" beteken 'n motorvoertuig, uitgesonderd 'n motorfiets met syspan, wat drie wiele het en ontwerp is om bestuur te word deur middel van die tipe kontroles waar mee 'n motorfiets gewoonlik toegerus is.
- 1.4 "**Motorkar**" beteken 'n motorvoertuig, uitgesonderd 'n motorfiets of motordriewiel, wat ontwerp of aangepas is uitsluitlik of hoofsaaklik vir die vervoer van hoogstens sestien (16) persone.
- 1.5 "**Ligte afleveringsvoertuig**" beteken motorvoertuie wat ontwerp of aangepas is vir die vervoer van persone en vrag met 'n tarra wat nie een komma vyf (1,5) ton oorskry nie en met geen swaar as soos omskryf in para graaf 1.7 hieronder nie.
- 1.6 "**As**" beteken enige toestel of stel toestelle, hetsy onafgebroke oor die breedte van die voertuig of nie, waarom die wiele van die voertuig ronddraai en wat so geplaas is dat wanneer die voertuig reguit vorentoe ry, die vertikale hartlyne van sodanige wiele in een vertikale vlak reghoekig met die langshartlyn van sodanige voertuig is.
- 1.7 "**Swaar as**" beteken 'n as waarvan die wiele toegerus is met bande met 'n grootte (spanranddeursnee) groter as 406,4 millimeter (16 duim), of 'n as met meer as twee (2) wiele, ongeag die bandgrootte, maar nie 'n as van 'n motorfiets, 'n motordriewiel of 'n motorkar nie.
- 1.8 "**Ligte voertuig**" beteken 'n motorvoertuig, uitgesonderd swaar voertuie soos hieronder beskryf.
- 1.9 "**Swaar voertuig**" beteken 'n motorvoertuig met minstens een swaar as.
- 1.10 "**Abnormale voertuig**" beteken 'n motorvoertuig wat die wettige afmetings, soos beskryf in die Padverkeerswet, 1989, of in enige ander wet oorskry.
- 1.11 "**Sleepwa**" beteken 'n voertuig wat nie self-aangedrewe is nie en wat ontwerp of ingerig is om deur 'n motorvoertuig getrek te word, maar sluit nie 'n syspan wat aan 'n motorfiets vasgeheg is in nie.

2. CLASSIFICATION OF MOTOR VEHICLES

Class I: Light vehicles

Light vehicles are motor vehicles, other than heavy vehicles as defined hereunder, with or without a trailer and include motor cycles, motor tricycles, motor cars and light delivery vehicles.

2. KLASIFIKASIE VAN MOTORVOERTUIE

Klas I: Ligte voertuie

Ligte voertuie is motorvoertuie, uitgesonderd swaar voertuie soos hieronder omskryf, met of sonder sleepwa, en sluit motorfiets, motordriewiele, motorkarre en ligte afleveringsvoertuie in.

Class II: Medium heavy vehicles

Medium heavy vehicles are heavy vehicles, with two axles.

Class III: Large heavy vehicles

Large heavy vehicles are heavy vehicles, with three or four axles.

Class IV: Extra large heavy vehicles

Extra large heavy vehicles are heavy vehicles with five or more axles.

3. AMOUNTS OF TOLL

3.1 The amount of toll payable for a trip on the toll road shall be as follows:

- CLASS I: R1,30.
- CLASS II: R1,50.
- CLASS III: R2,20.
- CLASS IV: R3,80.

3.2 A rebate of 20 per cent on the amount of toll specified above shall be granted to all persons or organisations with an approved deposit account. Such a deposit account requires a minimum deposit of R300 or the value of three months' usage of the toll road, whichever is the greater.

3.3 A rebate of 20 per cent on the amounts of toll specified above shall be granted to all users of the Pelindaba Toll Road when more than 20 trips are undertaken during a calender month with a single Fleet Management or a Transkard card which has been approved by the Department of Transport. This usage and rebate will only be available when equipment for such payment method becomes available at the plaza.

3.4 A rebate on the amount of toll specified above shall be granted to light vehicles passing through the Pelindaba Toll Plaza who tender valid "Frequent User Cards" approved by the Department of Transport as set out hereunder:

- (a) For 20 to 40 trips per single card during a calender month—20% discount.
- (b) For more than 40 trips per single card during a calender month—40% discount.

This usage and rebate will only be available when equipment for such payment method becomes available at the plaza.

3.5 A fixed monthly toll fee of **R35,00** payable in advance and covering toll payment for up to 60 trips per calender month by light vehicles, will be charged to commuters or regular users tendering the Department of Transport Commuter Concession Card, as a special concession tariff. This concession will lapse when the rebate mentioned in paragraph 3.4 becomes operational.

Klas II: Medium swaar voertuie

Medium swaar voertuie is swaar voertuie met twee asse.

Klas III: Groot swaar voertuie

Groot swaar voertuie is swaar voertuie met drie of vier asse.

Klas IV: Ekstra groot swaar voertuie

Ekstra groot swaar voertuie is swaar motorvoertuie met vyf of meer asse.

3. BEDRAE VAN TOL

3.1 Die tolbedrae betaalbaar vir 'n rit op die tolpad is soos volg:

- KLAS I: R1,30.
- KLAS II: R1,50.
- KLAS III: R2,20.
- KLAS IV: R3,80.

3.4 'n Korting soos uitgesit hieronder, op die tolbedrae soos hierbo vermeld, word toegestaan aan ligte voertuie wat deur die Pelindaba-tolplaza beweeg wat 'n geldige "Gereelde Gebruikerskaart", goedgekeur deur die Departement van Vervoer, vir betaling aanbied:

- (a) Vir 20 tot 40 ritte per enkel gebruikerskaart gedurende 'n kalendermaand—20% afslag.
- (b) Vir meer as 40 ritte per enkel gebruikerskaart gedurende 'n kalendermaand—40% afslag.

4. The Magalies Toll Road shall be open to all traffic for 24 hours a day.
5. The date upon and the time at which the said amounts of toll shall become payable at the Pelindaba Toll Plaza shall be **1 October 1993 at 06:00**.

- 1.6 "Axle" means a device or set of devices, whether continuous across the width of the vehicle or not, about which the wheels of the vehicle rotate and which is so placed that, when the vehicle is travelling straight ahead, the vertical centre-lines of such wheels are in one vertical plane at right angles to the longitudinal centre-line of such vehicle.
- 1.7 "Heavy axle" means an axle the wheels of which are fitted with tyres of a size (bead seat diameter) greater than 406,4 millimetres (16 inches), or an axle with more than two (2) wheels irrespective of tyre size but excluding any axle of a motor cycle, a motor tricycle or a motor car.

2. CLASSIFICATION OF MOTOR VEHICLES

Class I: Light vehicles

2. CLASSIFICATION OF MOTOR VEHICLES

Class I: Light vehicles

Light vehicles are motor vehicles, other than heavy vehicles as defined hereunder, with or without a trailer and include motor cycles, motor tricycles, motor cars and light delivery vehicles.

Class II: Medium heavy vehicles

Medium heavy vehicles are heavy vehicles, with two axles.

Class III: Large heavy vehicles

Large heavy vehicles are heavy vehicles, with three or four axles.

BYLAE

1. WOORDOMSKRYWING

- 1.1 "Motorvoertuig" beteken 'n geheel bestaande uit een of meer meganies aangedrewe eenhede met of sonder sleepwa of sleepwaens wat fisies aan mekaar gekoppel is deur middel van sleepstange, sleeptoue of meganiese geleiding en ook—

 - (a) 'n motorfiets;
 - (b) 'n motordriewiel;
 - (c) 'n motorkar;

- (d) a vehicle which has pedals and a mechanically powered unit as an integral part thereof or attached thereto and which is designed or adapted to be propelled by means of either such pedals or such mechanical unit or both; and
- (e) a light delivery vehicle (a bakkie).
- 1.2 "**Motor cycle**" means a motor vehicle which has two wheels and includes any such vehicle having a side-car attached thereto.
- 1.3 "**Motor tricycle**" means a motor vehicle, other than a motor cycle with a side-car, which has three wheels and which is designed to be driven by means of the type of controls usually fitted to a motor cycle.
- 1.4 "**Motor car**" means a motor vehicle, other than a motor cycle or a motor tricycle, designed or adapted solely or principally for the conveyance of persons not exceeding sixteen (16) in number.
- 1.5 "**Light delivery vehicle**" means a motor vehicle designed or adapted for the conveyance of persons and freight with a tare not exceeding one comma five (1,5) ton and with no heavy axle as defined in paragraph 1.7 hereunder.
- 1.6 "**Axle**" means a device or set of devices, whether continuous across the width of the vehicle or not, about which the wheels of the vehicle roataate and which is so placed that, when the vehicle is travelling straight ahead, the vertical centre-lines of such wheels are in one vertical plane at right angles to the longitudinal centre-line of such vehicle.
- 1.7 "**Heavy axle**" means an axle the wheels of which are fitted with tyres of a size (bead seat diameter) grater than 406,4 millimetres (16 inches), or an axle with more than two (2) wheels irrespective of tyre size but excluding any axle of a motor cycle, a motor tricycle or a motor car.
- 1.8 "**Light vehicle**" means a motor vehicle, other than heavy vehicles as defined hereunder.
- 1.9 "**Heavy vehicle**" means a motor vehicle with at least one heavy axle.
- 1.10 "**Abnormal vehicle**" means a motor vehicle exceeding the legal dimensions as described in the Road Traffic Act, 1989, or in any other law.
- 1.11 "**Trailer**" means a vehicle which is not self-propelled and which is designed or adapted to be drawn by a motor vehicle but does not include a side-car attached to a motor cycle.
- (d) 'n voertuig met pedale en met 'n meganiese aangedrewe eenheid as 'n integreerde deel daarvan of daarvan vasgeheg en wat ontwerp of aangepas is om óf deur middel van sodanige pedale of deur middel van die meganiese eenheid óf deur albei voortbeweeg te word; en
- (e) 'n ligte afleveringsvoertuig ('n bakkie).
- 1.2 "**Motorfiets**" beteken 'n motorvoertuig met twee wiele en ook enige sodanige voertuig waaraan 'n syspan geheg is.
- 1.3 "**Motordriewiel**" beteken 'n motorvoertuig, uitgesonderd 'n motorfiets met syspan, wat drie wiele het en ontwerp is om bestuur te word deur middel van die tipe kontroles waar mee 'n motorfiets gewoonlik toegerus is.
- 1.4 "**Motorkar**" beteken 'n motorvoertuig, uitgesonderd 'n motorfiets of motordriewiel, wat ontwerp of aangepas is uitsluitlik of hoofsaaklik vir die vervoer van hoogstens sesien (16) persone.
- 1.5 "**Ligte afleveringsvoertuig**" beteken motorvoertuie wat ontwerp of aangepas is vir die vervoer van persone en vrag met 'n tarra wat nie een komma vyf (1,5) ton oorskry nie en met geen swaar as soos omskryf in para graaf 1.7 hieronder nie.
- 1.6 "**As**" beteken enige toestel of stel toestelle, hetsy onafgebroke oor die breedte van die voertuig of nie, waarom die wiele van die voertuig ronddraai en wat so geplaas is dat wanneer die voertuig reguit vorentoe ry, die vertikale hartlyne van sodanige wiele in een vertikale vlak reghoekig met die langshartlyn van sodanige voertuig nie.
- 1.7 "**Swaar as**" beteken 'n as waarvan die wiele toegerus is met bande met 'n groote (spanranddeursnee) groter as 406,4 millimeter (16 duim), of 'n as met meer as twee (2) wiele, ongeag die bandgrootte, maar nie 'n as van 'n motorfiets, 'n motordriewiel of 'n motorkar nie.
- 1.8 "**Ligte voertuig**" beteken 'n motorvoertuig, uitgesonderd swaar voertuie soos hieronder beskryf.
- 1.9 "**Swaar voertuig**" beteken 'n motorvoertuig met minstens een swaar as.
- 1.10 "**Abnormale voertuig**" beteken 'n motorvoertuig wat die wettige afmetings, soos beskryf in die Padverkeerswet, 1989, of in enige ander wet oorskry.
- 1.11 "**Sleepwa**" beteken 'n voertuig wat nie self-aangedrewe is nie en wat ontwerp of ingerig is om deur 'n motorvoertuig getrek te word, maar sluit nie 'n syspan wat aan 'n motorfiets vasgeheg is in nie.

2. CLASSIFICATION OF MOTOR VEHICLES

Category 1: Light vehicles

Lights vehicles are motor vehicles, other than heavy vehicles as defined hereunder.

Category 2: Heavy vehicles

Heavy vehicles are motor vehicles, with at least one truck axle.

3. AMOUNTS OF TOLL

3.1 The amounts of toll for a trip on the whole length of the toll road between the Warmbaths Interchange and Middelfontein shall be as follows:

(a) **Category 1:**

Light vehicles—R3,10 per axle with wheels in contact with the road surface up to and including a maximum toll of R12,40 (four axles).

(b) **Category 2:**

Heavy vehicles—R5,00 per axle with wheels in contact with the road surface up to and including a maximum toll of R25,00 (five axles).

3.2 The amount of toll for a trip on the toll road between the Warmbaths Interchange and the Nylstroom Interchange shall be as follows:

(a) **Category 1:**

Light vehicles—R1,30 per axle with wheels in contact with the road surface up to and including a maximum toll of R5,20 (four axles).

(b) **Category 2:**

Heavy vehicles—R2,60 per axle with wheels in contact with the road surface up to and including a maximum toll of R13,00 (five axles).

3.3 A rebate of 20 per cent shall be granted to motor vehicles in both categories when debit cards with a maximum face-value of R500 are purchased simultaneously and to all persons who have an approved deposit account.

4. The Kranskop Toll Road shall be open to all traffic for 24 hours per day.

5. The date upon and the time at which the said amounts of toll shall become payable at the Kranskop Toll Plaza shall be **1 October 1993 at 06:00**.
