FILM

The Publications Appeal Board under section 24 of the Publications Act, 1974, as amended, has decided that the undermentioned film is not undesirable within the meaning of section 47 (2) of the Act by stipulating—

- (a) that it may not be exhibited to persons under 18 years of age;
- (b) that the distributors issue a warning to viewers, indicating that it is a film for adults, with explicit violence and crude language, as indicated by the letters LV; and
- (c) that excisions be made.
