**ACT****To authorize certain unauthorized expenditure from the Revenue Account: House of Assembly.**

**B**E IT ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:—

**Defraying of unauthorized expenditure with regard to Education and Culture from Revenue Account: House of Assembly**

1. (1) The Revenue Account: House of Assembly is hereby charged with the amount of R40 330,00 to defray certain expenditure over and above the amounts appropriated for the financial years which ended on 31 March 1987, 31 March 1991 and 31 March 1992 in respect of the vote Education and Culture (Vote No. 3). 5

(2) The expenditure referred to in subsection (1) is more fully described in paragraph 1(1), on page 4, of the Report of the Auditor-General on the Appropriation and Miscellaneous Accounts in respect of the Administration: House of Assembly for 1991-92 [RP 94/1993], which has been submitted to the House of Assembly, and in the Report of the House Committee on Public Accounts: House of Assembly, 1993. 10

**Defraying of unauthorized expenditure with regard to Local Government, Housing and Works from Revenue Account: House of Assembly** 15

(1) The Revenue Account: House of Assembly is hereby charged with the amount of R1 051 722,14 to defray certain expenditure over and above the amounts appropriated for the financial years which ended on 31 March 1987, 31 March 1988, 31 March 1989 and 31 March 1990 in respect of the vote Welfare (Vote No. 7). 40
