PRIVATE ACT

To amend the University of Natal (Private) Act, 1960, so as to provide that the University of Natal may also conduct its activities outside its seat; and to provide for matters connected therewith.

Preamble

WHEREAS the University of Natal (hereinafter referred to as the University) was incorporated by the University of Natal (Private) Act, 1960 (Act No. 7 of 1960) (hereinafter referred to as the principal Act), and the principal Act was amended by the University of Natal (Private) Amendment Act, 1977 (Act No. 66 of 1977), the University of Natal (Private) Amendment Act, 1979 (Act No. 71 of 1979), the University of Natal (Private) Amendment Act, 1983 (Act No. 71 of 1983), the Universities Amendment Act, 1983 (Act No. 83 of 1983), the Universities, National Education Policy and Technikons Amendment Act, 1984 (Act No. 75 of 1984), and the Universities Amendment Act (House of Assembly), 1989 (Act No. 64 of 1989); 5 10

AND WHEREAS for the better administration and conduct of the University it is expedient to further amend the principal Act so as to provide that the University may also conduct its activities outside its seat:

BE IT THEREFORE ENACTED by the State President and the House of Assembly of the Republic of South Africa, as follows:15

Amendment of section 2 of Act 7 of 1960, as substituted by section 1 of Act 71 of 1979

1. Section 2 of the principal Act is hereby amended by the substitution for subsection (1) of the following subsection:

“(1) The University shall as heretofore be a body corporate with its seat at Pietermaritzburg and at Durban [**in the Province of Natal**]: Provided that—

- (i) the University may, with the approval of the Minister, also conduct its university activities outside its seat;
- (ii) if a subject is taught within the seat of another university or at a place where the university activities of another university are carried on under the Act of that university or with the approval of the Minister, such subject shall be taught with the approval of that other university and the Minister; and

EN NADEMAAL dit vir die beter administrasie en bestuur van die Universiteit dienstig is om die Hoofwet verder te wysig ten einde te bepaal dat die Universiteit sy bedrywighede ook buite sy setel kan uitoefen:

Wysiging van artikel 2 van Wet 7 van 1960, soos vervang deur artikel 1 van Wet 71 van 1979

1. Artikel 2 van die Hoofwet word hierby gewysig deur subartikel (1) deur die 20 volgende subartikel te vervang:

“(1) Die Universiteit is soos tot nog toe 'n regpersoon met sy setel in Pietermaritzburg en in Durban [in die provinsie Natal]: Met dien verstande dat—
25 (i) die Universiteit met die goedkeuring van die Minister sy universitaire bedrywighede ook buite sy setel kan uitoefen;
(ii) indien 'n vak gedoseer word binne die setel van 'n ander universiteit of op 'n plek waar die universitaire bedrywighede van 'n ander universiteit kragtens die Wet van daardie universiteit of met die goedkeuring van die Minister voortgesit word, sodanige vak met die goedkeuring van 30 daardie ander universiteit en die Minister gedoseer word; en

- (iii)** the University may also conduct its university activities in any hospital or hospital department approved by the South African Medical and Dental Council as a satellite hospital or a satellite hospital department or in any health clinic assigned by a health authority to the University for training purposes.”.

- 2.** This Act shall be called the University of Natal (Private) Amendment Act (House of Assembly), 1993.
