# ACT

To appropriate an adjusted amount of money for the requirements of the State in respect of the financial year ending 31 March 1994.

**B**E IT ENACTED by the State President and the Parliament of the Republic of South Africa, as follows:—

## **Appropriation of adjusted amounts of money for requirements of State, excluding provinces**

Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the State, excluding the provinces, in respect of the financial year ending 31 March 1994, as a charge to the State Revenue Account, the adjusted amounts of money shown in column 1 of Schedule 1. 5

## **Appropriation of adjusted amounts of money for requirements of province of the Cape of Good Hope**

2. Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of the Cape of Good Hope in respect of the financial year ending 31 March 1994, as a charge to the Account for Provincial Services: Cape, the adjusted amounts of money shown in column 1 of Schedule 2. 15

## **Appropriation of adjusted amounts of money for requirements of province of Natal**

3. Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of Natal in respect of the financial year ending 31 March 1994, as a charge to the Account for Provincial Services: Natal, the adjusted amounts of money shown in column 1 of Schedule 3. 20

## **Appropriation of adjusted amounts of money for requirements of province of the Orange Free State**

## **Appropriation of adjusted amounts of money for requirements of province of the Transvaal**

Subject to the provisions of the Exchequer Act, 1975 (Act No. 66 of 1975), there are hereby appropriated out of the State Revenue Fund for the requirements of the province of the Transvaal in respect of the financial year ending 31 March 1994, as a charge to the Account for Provincial Services: Transvaal, the adjusted amounts of money shown in column 1 of Schedule 5. 30
