 (b) the insertion of the word "Mbekweni" in the column for Cape Province under grade 5 after the word "Lingelihle".
8. By—
 (a) the insertion of the word "Mfuleni" in the column for Cape Province under grade 3 after the word "Masibambane".
9. By—
 (a) the insertion of the word "Nkululeko" in the column for Cape Province under grade 2 after the word "Murraysburg".
10. By—
 (a) the insertion of the word "Nthorwane" in the column for Transvaal under grade 2 after the word "Mofulatshepe".
11. By—
 (a) the deletion of the word "Sibongile" where it appears in the column for Orange Free State under grade 4; and
 (b) the insertion of the word "Sibongile" in the column for Natal under grade 4 after the word "Shelly Beach".

 (a) the insertion of the word "Steynsrus" in the column for Orange Free State under grade 2 after the word "Springfontein".
