PROPOSED LEVY ON DRIED BEANS

I, André Isak van Niekerk, Minister of Agriculture, acting under section 84A (6) of the Marketing Act, 1968 (Act No. 59 of 1968), hereby —

- (a) give notice of my intention to impose a levy of R15,00 (VAT included) per ton dried beans sold by the producer thereof in the Republic; and
- (b) invite producers of dried beans to make such representations thereanent as they may think fit, by lodging it in writing with the Director-General, Department of Agriculture, Private Bag X250, Pretoria, 0001, within four weeks of the date of publication of this notice.
