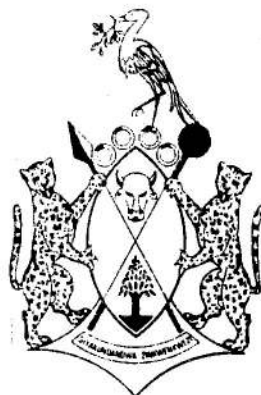

It is hereby notified that the Deputy Chairman of the Council of State has assented to the following decree which is hereby published for general information:-

COUNCIL OF STATE — REPUBLIC OF CISKEI

CONSTITUTION AMENDMENT DECREE, 1994

DECREE

To amend the Republic of Ciskei Constitution Decree, 1990.

[English text signed by the Chairman of the Council of State. Assented to on 19 January 1994.]

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

1. Insertion of section 20A in Decree 45 of 1990. - The following section is hereby inserted in the Republic of Ciskei Constitution Decree, 1990 after section 20:

"20A. Deputy Ministers. - (1) The Chairman may from time to time appoint persons to hold office during his pleasure as Deputy Ministers of any specified departments of State or Deputy Ministers of such other description as the Chairman may determine.

(2) (a) A Deputy Minister shall exercise and perform on behalf of a Minister any of the powers, duties and functions entrusted to such Minister under any law which may, subject to any directions of the Chairman, be assigned to him by the said Minister.

(b) Any reference in any such law as aforesaid to the Minister shall be construed as including a reference to a Deputy Minister acting in pursuance of an assignment under paragraph (a) by that Minister.

(3) A person appointed under subsection (1) shall not, unless the Chairman has otherwise directed, be a member of the Council of Ministers.

(4) The remuneration of a Deputy Minister and the portion thereof which shall be non-taxable shall be determined by the Chairman and shall be payable out of moneys appropriated by law for the purpose.

(5) Any person appointed as Deputy Minister shall, before assuming the duties of his office, make and subscribe before a Judge of the Supreme Court or other person designated by the Chairman the following oath:

"I do hereby swear to be faithful to the people of Ciskei, to hold my office as Deputy Minister with honour and dignity, to uphold the laws of the Republic, to perform the duties of my office diligently and conscientiously and without regard to my own advantage or benefit and to keep secret any matters entrusted to me under secrecy.
So help me God."

Short title and commencement. - This decree shall be called the Constitution Amendment Decree, 1994 and shall be deemed to have come into operation on 19 January 1994.
