# LEVYING OF RATES AND CHARGES: ELECTRICITY RETICULATED BY THE ELECTRICITY DIRECTORATE OF THE DEPARTMENT OF PUBLIC WORKS

Under and by virtue of the powers vested in me by section 14 of the Electricity Act, 1958 (Act No. 40 of 1958) read with Section 72 of the Republic of Ciskei Constitution Act, 1981 (Act No. 20 of 1981) I, Jacobus Willem Abraham Van Der Merwe, Minister of the Department of Public Works, hereby levy the rates and charges set out in the accompanying schedule in respect of electricity supplied by the Department of Public Works to consumers within Ciskei.

The said rates and charges shall be applicable in respect of electricity supplied with effect from 01 January 1994.

#### SCHEDULE

## 1. TARIFF A: BULK AND LARGE POWER TARIFF

For electricity supplied to a consumer whose notified maximum demand is 25 kilowatts/kilovolt amperes or over, in the form of a three-phase alternating current at a frequency of 50 hertz and at an agreed voltage which is available in the vicinity.

 Basic charge per point of supply per month whether any electricity is used or not

R143,47 (125,85+VAT)

b) Demand charge per kV.A per month for supply

at voltage below 400 volts Above 400 and below 66 000 volts R32,36 (28,38+VAT) R31,08 (27,26+VAT)

c) Energy charge per kW.H

5,97c (5,230+VAT)

d) Transmission charge at 3% on above items (sum of a, b & c).

#### 2. TARIFF B: URBAN SMALL POWER TARIFF

For the supply of electricity for purposes other than domestic to a consumer within a legally constituted township or within an area considered by the Department of Public Works to be equivalent thereto. The maximum demand of such supply at no time will exceed 100 kV.A and being made available at a nominal voltage of 400 volts or as otherwise agreed.

a) Monthly basic charge for a supply, payable whether electricity is used or not.

for a supply up to 25 kV.A for a supply above 25kV.A to 50kV.A for a supply above 50kV.A to 100kV.A R41,45 (36,36+Vat) R66,95 (58,78+Vat) R114,78 (100,68+Vat)

b) Energy Charges per kW.h

#### 3. TARIFF C: DOMESTIC TARIFF

For a supply of electricity for domestic purposes for a dwelling unit or a group of dwelling units, or for a church, hall, old age home or the like premises, within a legally constituted township or within an area considered by the Department of Public Works to be a legally constituted township.

a) Monthly basic charge

R34,24 (30,04+Vat)

b) Energy charge per kW.h consumed

## 4. TARIFF D: RURAL SMALL POWER TARIFF

For a supply of electricity to a consumer whose maximum demand at no time exceeds 100 KVA made available at a nominal voltage lower than 400 volts or as otherwise agreed.

a) Monthly basic charge for a small supply up to 25kV.A R70,17 (61,55+Vat) for a supply above 25kV.A to 50 kV.A R95,64 (83,89+Vat)

b) Energy charge per kW.h for first 1000kW.h consumed monthly per kW.h for each kW.h taken in excess of 1000kW.h 15,94c (13,98+Vat)

#### 5. TARIFF E: STREET LIGHTS

Where the Department of Public Works provides a supply for, and maintains, any street lighting or similar public lighting.

Dusk to dawn per 100 watts per month

R4,77 (4,18+Vat)

# 6. TARIFF F1: LARGE POWER USERS (INDUSTRIAL AREAS)

For the supply of electricity other than domestic to a consumer whose notified demand is 25 kilovolts/kilovolt amperes or over, in the form of a three phase alternating current at a frequencey of 50 hertz and at an agreed voltage which is available in the vicinity.

Applicable to a supply of electricity for all purposes to a consumer whose maximum demand exceeds 25kV.A.

a) A service charge of R143,47 (125,47+Vat) per month payable whether or not any electricity is used.

b) Demand charge per KVA per month at 400 volt above 400 and below 66 000 volts R32,36 (28,36+Vat)

c) Energy charge per kW.h 5,97c (5,23c+Vat)

# 7. TARIFF F2: SMALL COMMERCIAL POWER USERS (INDUSTRIAL AREAS)

For a supply of electricity for purposes other than domestic to a consumer within an industrial area within a area considered by the Department of Public Works to be equivalent thereto. The maximum demand of such supply at no time will exceed 100 kV.A and being made available at a nominal voltage of 400 volts or as otherwise agreed.

a) Monthly basic charge for a supply, payable whether electricity is used or not

for a supply up to 25 kV.A R41,45 (36,36+Vat) R66,95 (58,78+Vat) R67 a supply above 50kV.A to 100kV.A R114,78 (100,68+Vat)

b) Energy charges per kW.h

for the first 500kW.h consumed monthly P27,57 (24,18+Vat) per kW.h for each kW.h taken in excess of 500kW.h 15,94c (13,98+Vat)

# 8. TARIFF F3: TIME OF USE TARIFF FOR LARGE POWER USERS (INDUSTRIAL AREAS)

Where the Department is able to arrange a time of use tariff with ESKOM, the charge for such supply and service will be fixed by special agreement between PUBLIC WORKS and the industrial consumer.

#### 9. TARIFF G: SMALL SUPPLY - PREPAYMENT

For a single-phase supply of electricity to a consumer within an area designated by PUBLIC WORKS as an area in which a prepayment measurement system is applicable, the consumer shall pay in advance for each kW.h of electrical energy supplied at one of the following rates:

- G1 24,82c (21,77+Vat) in the case where the total cost of providing the supply is recovered from the consumer by means of the tariff and where the monthly consumption is expected to be less than 500 kW.h.
- G2 21,22c (18,61†Vat) in the case where the capital cost of the local electricity infrastructure, excluding the service connection costs (service cable/line, electricity dispenser, readyboard, etc.), has been paid for in advance by the consumer(s) or another party.
- G3 18,62c (16,33+Vat) in the case where the capital cost of the local electricity infrastructure has been fully paid for in advance by the consumer(s) or another party.

Energy charges other than G1, G2 and G3 may in PUBLIC WORKS' discretion be applied in cases where the capital cost of the local electricity infrastructure has only been partially paid for by consumer(s) or another party.

#### 10. OTHER SERVICES/CHARGES

- 11. Payments are due on the date indicated on the account submitted to consumers. Failure to pay by the specified date may result in discontinuation of supply in which case a reconnection fee as indicated in 8(c) will be required prior to re-instatement of electrical supplies.
- 12. Value Added Tax has been included on all charges for electricity consumptions and other services except on items 1(d) and 11(a).
