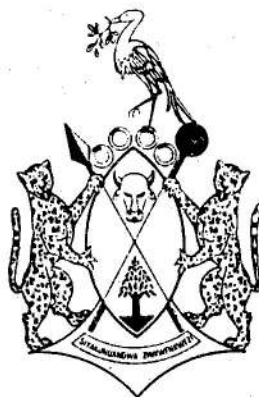

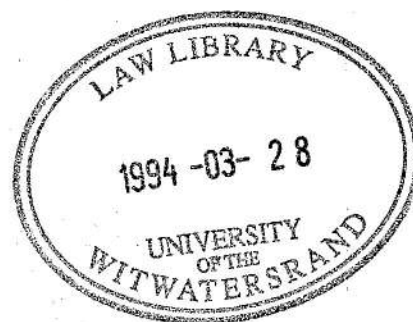

# COUNCIL OF STATE — REPUBLIC OF CISKEI

## PREPARATORY ADMINISTRATION DECREE, 1994

### DECREE

To provide for the incorporation into the law of Ciskei of certain enactments of the Republic of South Africa, to make provision for the application of such enactments and to provide for incidental matters.

*[English text signed by the Chairman of the Council of State. Assented to on 3 February 1994.]*

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows:-

**1. Definitions.** - In this decree, unless the context indicates otherwise -  
"Ciskei" means the Republic of Ciskei; and  
"the Constitution Decree" means the Republic of Ciskei Constitution Decree, 1990 (Decree 45 of 1990).

**2. Incorporation of certain legislative enactments of the Republic of South Africa into law of Ciskei and application of such enactments.** - (1) (a) Subject to the provisions of subsection (2), the enactments of the Republic of South Africa mentioned in the Schedule are hereby incorporated into the law of Ciskei.

(b) For the purposes of the application in Ciskei of the said laws -

(i) any agreement entered into by the Government of Ciskei as contemplated in section 2(4) of the Independent Electoral Commission Act, 1993 (Act No. 150 of 1993) shall have the force of law;

(ii) the Independent Media Commission established by section 2 of the Independent Media Commission Act, 1993 (Act 148 of 1993) shall be competent to exercise and perform in respect of persons and matters in Ciskei all such powers, functions and duties as it may in terms of that Act exercise and perform in respect of persons and matters in the Republic of South Africa as contemplated in, and subject to the provisions of, section 31 of that Act;

(iii) the Independent Broadcasting Authority established by section 3 of the Independent Broadcasting Authority Act, 1993 (Act No. 153 of 1993) may exercise and perform in respect of persons and matters in Ciskei all such powers, functions and duties as it may in terms of the said Act exercise and perform in respect of persons and matters in the Republic of South Africa as contemplated in, and subject to the provisions of, section 79 of that Act.

(2) Nothing in subsection (1) contained shall be construed as abolishing, derogating from, diminishing, qualifying, impairing or affecting in any manner whatsoever -

(a) the sovereignty and independence of Ciskei;

(b) the powers, prerogatives, authorities and functions of the Head of State, the Council of State, the Executive Authority and the Legislative Authority of Ciskei referred to in Chapters IV, V, VI and VII of the Constitution Decree;

(c) the powers, authorities and functions of the judicial authority contemplated in Chapter VIII of the Constitution Decree and dealt with more fully in the Supreme Court Decree, 1990 (Decree 43 of 1990);

(d) citizenship, the administration of justice and administration generally for which provision is made in the Constitution Decree and the other laws of Ciskei;

(e) the competency generally of the Ministers of State; and

(f) any fundamental right or freedom conferred by or under or set out in Schedule 6 of the Constitution Decree or any right whatsoever of any person.

**3. Short title.** - This decree shall be called the Preparatory Administration Decree, 1994.
