ALTERNATIVE ROUTE DURING OFF-PEAK PERIODS—FORWARD: As per above route to Kings Avenue, then Republic Road, Rabie Street, Hester Road, Philip le Roux Ave, Hans Schoeman St, Hill St, Kent Avenue, Harley St, Selkirk, Jan Smuts Ave, then as per existing route.

RETURN: As per existing route to Ameshoff Street, then as above alternative route in reverse.

RESTRICTION: On journeys to Johannesburg no passengers to be picked up after leaving Philip le Roux Street, (Malanshof). On journeys from Johannesburg no passengers to be set down before Philip le Roux Street, (Malanshof).

ALTERNATIVE RESTRICTION: Additional journeys, as and when required, with authority to operate between either terminus and any intermediate point en route.

SERVICE 5: JOHANNESBURG—KLERKSDORP

ROUTE: Between Klerksdorp and Johannesburg from bus terminus at Town Hall, Klerksdorp via R29, Potchefstroom and R29 to Johannesburg terminus at Leyds Street, returning via same route.

Routes and termini in towns to be operated as specified by the local authorities in each town.

SERVICE 6: POTCHEFSTROOM—DURBAN

Through Johannesburg on routes as specified by the Local Authority, then via M1, N1, Ben Schoeman Highway, continuing on N1 past Pretoria, via Warmbaths, Nylstroom, Naboomspruit and Potgietersrus to terminus to Pietersburg on routes as specified by the Local authority.

Alternative route forward: As per forward route up to Pretoria, along Ben Schoeman Highway and Potgieter Street, through Pretoria on routes as specified by the Local Municipal Authority, rejoining the N1 via roads specified by the Local Authority, and then as per forward route to Pietersburg.

Return routes: As per forward routes, and through towns and Cities on routes as specified by the various Local Authorities.

Restriction: No intermediate passengers may be conveyed between Johannesburg and Pretoria, both points inclusive.

No non-white passengers, may be picked up and set down between Naboomspruit and Potgietersrus both points inclusive on either the forward or return journeys.

No intermediate passengers will be picked up and set down between Pretoria and Soweto both points inclusive on either the forward or return journeys.

Note: All routes through towns and Cities as per agreement with the Local Authorities. The holder is authorised to short turn at points along the route subject to existing restrictions.

SERVICE 8: JOHANNESBURG—PRETORIA

Route forward: As per existing authority namely Loveday Street, De Villiers Street, Harrison Street, then Wolmarans Street, Viljoen Street, Smit Street, M1 then as per existing authority namely N1, Ben Schoeman Highway (Pretoria), Potgieter Street, Struben Street, Prinsloo Street, Schoeman Street, Du Toit Street terminus.

Route return: Du Toit Street, Pretorius Street, Van der Walt Street, Proes Street, Schubart Street, Minnaar Street, Potgieter Street (alternatively from Schubart Street along new section on road past Minnaar Street, connecting directly with Potgieter Street) then as forward route in reverse direction as far as Smit Street then as per existing authority namely Harrison Street, Kerk Street, Loveday Street terminus.

Alternative route: Use of R101 or sections thereof between Kramerville and Verwoerdburg off-ramps.

Routes and stops within towns and cities as directed by the Municipal authorities.

Restriction: No intermediate passengers may be conveyed within any single Municipal area.

Additional journeys over entire or part of route as and when required including Saturdays and Sundays. Intermediate stops when necessary.

Restriction: Subject to the condition (1) that only passengers in possession of through tickets to or from points beyond Pretoria and/or Johannesburg may be conveyed, and no local passengers may be conveyed between Pretoria and Johannesburg, both points inclusive; and (2) that the passengers be in possession of tickets for conveyance further than Johannesburg en route on an intercity service.

Alternative Route 2: As per existing authorised route to Witbank then R544 Vandyksdrif, R542, R38 Hendrina, Carolina, then continue on authorised route to Oshoek border post, returning via the same route.

Alternative Route 3: Johannesburg, Leyds Street, Harrison Street, Wolmarans Street, Smit Street, on ramp to M1 South, M2 East, N3 South, N17 Springs, R29 Bethal, R29 Ermelo, R39 Oshoek border post returning via the same route.

Alternative Route 4: As for route 3 above to N3 South then R550 Nigel, R550 Devon, R29 Bethal then continue as route 3 to Oshoek border post, returning via the same route.

SERVICE 10: JOHANNESBURG—NELSPRUIT

Route forward: Johannesburg (Leyds Street terminus) N1 to Pretoria - N4 to Witbank - Middelburg - Nelspruit.

Route return: As for forward route in reverse direction.

Alternative route forward: Johannesburg (Leyds Street terminus) - R22 to Witbank then N4 as for forward route above.

Alternative route return: As alternative route forward in reverse direction.

Restriction: No intermediate passengers within any Municipality or between Johannesburg and Pretoria.

Stops and routes through towns and cities as directed by the local Municipal Authorities.

SERVICE 11: JOHANNESBURG - KOMATIPOORT

Route forward: Johannesburg (Leyds Street terminus) via Harrison Street, Wolmarans Street, Viljoen Street, Smit Street, M1 North, N1 to Pretoria, N4 to Witbank, Middelburg, Nelspruit, Komatipoort.

Route return: As for forward route, entering Johannesburg at Braamfontein off-ramp Smit Street, Loveday Street and terminus in Leyds Street.

Alternative route forward: Johannesburg (Leyds Street terminus) - R22 to Witbank, then N4 as for forward route above.

Alternative route return: As alternative route forward in reverse direction.

Restrictions: No intermediate passengers within any Municipality or between Johannesburg and Pretoria.

Stops and routes through towns and cities as directed by the Local Municipal authorities.

SERVICE 12: JOHANNESBURG - DURBAN

Route forward: Johannesburg Leyds Street - Frederick Street - Simmonds Street - Village Road - M2 and N3 to Durban via Harrismith, and when required also Heidelberg - Villiers - Warden - Harrismith - Ladysmith - Estcourt - Mooiriver - Pietermaritzburg - Western Freeway - Commercial Road - Soldiers Way - Pine Street - Brickhill Road - West Street - Marine Parade Durban.

Route return: Durban Marine Parade - Rutherford Street - Point Road - Brickhill Road - Pine Street - Western Freeway - N3 then as forward route in reverse to M2 then Rissik Street - Wolmarans Street - Loveday Street - Leyds Street Johannesburg. (Note: Routes through towns as directed by the Local Municipal Authority).

Alternative routes forward:

(a) As forward route to Heidelberg the R23 to Ladysmith via Newcastle - National Road N3 to Durban as forward route.

(b) Johannesburg Leyds Street - Harrison Street - Marshall Street - John Page Drive - Jules Street - Stanhope Street - R29 - Johann Rissik Road - Germiston - R46 - Boksburg - M46 - Commissioner Street - M43 - R29 - Benoni - M45 - Brakpan - M45 - R554 - R51 - Springs - R51 - Nigel - R51 - Heidelberg - N3 (South) then as per existing route.

(c) Johannesburg Leyds Street - Harrison Street - Market Street - R24 - R22 - Boksburg off ramp - R21 - Boksburg then as route (b) above.

(d) Johannesburg Leyds Street - Harrison Street - Marshall Street - End Street - Heidelberg Road - M46 - R77 - N17 - Boksburg off ramp - R21 - Boksburg - then as route (b) above.

(e) As for route (b), (c) or (d) to Springs then R29 - Devon - Leandra - Evander - Trichardt - R77 - Secunda to R546 Junction - R546 - Charl Cilliers - R546 - Standerton - R23 - Volksrust - R23 - Newcastle - then as per existing route.

(f) As for route (e) as far as Standerton then R546 - Vrede - then as per existing route.

Alternative routes return: As alternative forward routes in reverse.

The conveyance authorised herein shall be subject to the following condition: No local passengers to be conveyed within the municipal areas of the town along the routes or be both picked up and set down between Johannesburg and Springs.

Alternate route: Between Johannesburg and Durban via route R26, R54 and N3 to Villiers, Harrismith, Ladysmith, Estcourt, Mooi River, Pietermaritzburg and Durban, returning via same route.

Stops and routes into and through towns and cities as directed by the local municipal authorities.

Stops and routes through towns and cities as directed by the Local Municipal authorities.

Restriction: No local passengers shall be conveyed within any municipality.

Route forward: Leyds St (Terminus) - Harrison St - Wolmarans St - Viljoen St - Smit St - 17th St - Bartlett St - High St - Portland St - Perth St - Main St (Johannesburg) - Ontdekkers Rd (Roodepoort) Voortrekker Rd - Tindall Rd - Main Reef Rd - R24 (Krugersdorp) R28 - To Westonaria - R29 - R501 - R500 - Carletonville - R500 - R29 via Potchefstroom - Klerksdorp - Wolmaransstad - Bloemhof - Warrenton - Kimberley - Britstown - Victoria West to Three Sisters N1 via Beaufort West - Laingsburg - turn off to Matjiesfontein - Touws River - Worcester and Paarl N1 to Cape Town - Table Bay Boulevard, Heerengracht - Adderley St - Darling St - Plein St - Golden Acre Terminus.

Route return: As forward route in reverse to Smit Street Johannesburg then Loveday Street - Leyds Street Terminus.

Alternative route: Forward 1: As route forward above to Smit Street then M1 - P29 to Potchefstroom then as route forward above, or via Smit Street, De Villiers Graaff Motorway - M2, R26, P156 - 3, P156 - 4 and N1 to Cape Town.

Alternative route return: As alternative forward route in reverse to Smit Street, Johannesburg then as route return above, or via N1, P156 - 4, P156 - 3, R26 and M2, Wessel Street and Smit Street.

Alternative Route A: As per existing route to Bloemfontein and Colesburg, then via N1 and R57 to Noupoot, Middelburg, Graaff Reinet and Aberdeen, then R61 to Beaufort West, and from Beaufort West to Cape Town as per existing authority, returning via same route.

Alternative Route B: As per existing route to Colesburg and Hanover, then via R32 to De Aar and Britstown, R29 to Victoria West and Three Sisters then via N1 and existing route to Cape Town, returning via same route.

Routes through the towns and cities may be changed as directed by the Local Municipal Authorities.

Additional journeys over entire, or part of route as and when required, or to connect with other coach services.

Restriction: No intermediate passengers may be carried between the terminus in Leyds Street and the corner of Ontdekkersweg and C. R. Swart Road.

SERVICE 15: JOHANNESBURG - GABORONE

Route: From terminus in Leyds Street Johannesburg, via Harrison Street, Wolmarans Street, Viljoen Street, Smit Street, 17th Street, Bartlett Street, High Street, Portland Street, Perth Street, Main Street, Ontdekkers Road, Voortrekker Road, Tindall Road, Main Reef Road, R24 to Magaliesberg, then R509 via Koster to Swartruggens, R27 to Zeerust and R505 to Kopfontein border post en route to Gaborone; returning via the same route, entering Johannesburg via Smit Street, Loveday Street to terminus in Leyds Street.

Routes through towns and cities may be changed as directed by the local authorities.

Additional journeys over entire or part of route as and when required.

Alternate route: Between Johannesburg and Gaborone via R24 to Krugersdorp, Magaliesberg and Rustenburg, then via R27 to Zeerust and R505 to Kopfontein Border post en route to Gaborone, returning via same route.

Stops and routes into and through towns and cities as directed by the local municipal authorities.

SERVICE 16: JOHANNESBURG - MOSSELBAY

Then via N1 to Beaufort West and R29 to De Rust. Alternate route: As per forward route to M1 South, M2 East, then via R26 to Vereeniging P156-3, P156-4 and N1 through Parys, Vredefort and Kroonstad to Bloemfontein and Colesburg, then via R57 to Middelburg, Graaff Reinet, Willowmore and Uniondale, then via R62 and R59 to George, then via N2 to Mossel Bay, returning via the same route, entering Johannesburg via M2, M1, Wessel Street, Smit Street, Loveday Street and terminus in Leyds Street.

Routes through towns and cities may be changed as directed by the local authorities.

Additional journeys over entire or part of route as and when required, or to co-ordinate with other coach services.

Stops and routes into and through towns and cities as directed by local municipal authorities.

Restriction: No local passengers shall be conveyed within any municipality.

Subject to the condition that no intermediate passengers will be picked up or set down between Pretoria and Johannesburg, both points inclusive.

SERVICE 19: BLOEMFONTEIN - DURBAN

Route: From terminus at Bloemfontein (as approved by the local authority) along roads as directed by the local authority and via R30 and N1 to Winburg, then via R49, Senekal and Bethlehem to Harrismith, and N3 to Ladysmith and Colenso, then via N3 to Estcourt turn-off (Road 10) and then via road 10 into Estcourt to stop in Estcourt as directed by the local authority. Return to N3 via R615 and road 170 (seven kilometres south of Estcourt) and continue along N3 via Mooi River and Pietermaritzburg to Durban, entering Durban from Western Freeway via City Off-ramp - Commercial Road - Soldier's Way - Pine Street - Brickhill Road - West Street - Marine Parade to terminus at Durban Transport Management Board Tour Office. Stops and routes through towns and cities as directed by the local Municipal Authorities.

Restriction: No local passengers shall be conveyed within any municipality.

Alternate Route: Between Bloemfontein and Durban via R64 Thaba Nchu, R64, R26, Ladybrand, Ficksburg, Bethlehem then via existing route namely R49 and N3 to Ladysmith and Colenso, then via N3 to Estcourt turn-off (Road 10) and then via Road 10 into Estcourt to stop in Estcourt as directed by the local authority. Return along same route to N1 and continue to Springfontein and Colesburg, then via R57 to Middelburg and Graaff-Reinet, then via R63 through Adendorp, Pearston and Somerset East to Cookhouse, then via R32 and N2 to terminus in Port Elizabeth (as approved by the local authority). ALTERNATE ROUTE VIA CRADOCK: As per forward route as far as Middelburg, then via R57 and R32 through Cradock and Cookhouse to N2, then via N2 to Port Elizabeth terminus (as approved by the Local Authority). Return via same route.

Stops and routes through towns and cities as directed by the municipal authorities.

ALTERNATE ROUTE: Between Bloemfontein and Port Elizabeth via N1 to Colesburg and R57 to Graaff-Reinet, then via R75 to Uitenhage and R368 to Port Elizabeth, returning via same route.

Stops and routes through towns and cities as directed by the municipal authorities.

Restriction: No local passengers shall be conveyed within any municipality.

Return via same route.

Stops and routes through towns and cities as directed by the Local Municipal Authorities.

Restriction: No local passengers shall be conveyed within any municipality.

SERVICE 23: BLOEMFONTEIN — CAPE TOWN

ROUTE: From terminus in Bloemfontein (as approved by the local authority) along roads as directed by the local authority, then via R706 to N1. From N1 turn off to Edenburg along R717 to stop in Edenburg as directed by the local authority. Return on roads as directed by the local authority, and R717 to the N1. Continue on N1 to tertiary road turnoff to Trompsburg. Into Trompsburg on tertiary road and roads as directed by the local authority. Return along same route to N1, and continue on N1 via Springfontein, Colesburg, Hanover, Richmond, Beaufort West, Laingsburg, turning off N1 to Worcester, return to N1 and proceed to Paarl, via N1 and R303. From Paarl via R45 to N1 and follow N1 to Cape Town, then on roads as directed by the local authority to terminus in Cape Town as approved by the local authority. Return to Bloemfontein via same route.

Stops and routes through towns and cities as directed by the Local Municipal Authorities.

Restriction: No local passengers shall be conveyed within any municipality.

SERVICE 24: JOHANNESBURG — RICHARD'S BAY

ROUTE: From terminus at Leyds Street, Johannesburg via Harrison Street, Wolmarans Street, Viljoen Street, Smit Street, M1 South, M2 East and N3 to Heidelberg, then R23 to Standerton, Volksrust and Newcastle. Then via R68 past Dundee and Nqutu to Melmouth. Then via R34 to Empangeni and Richards Bay, returning via the same route, entering Johannesburg via M2 West, M1 North, Braamfontein Off-ramp, Smit Street, Loveday Street to terminus in Leyds Street.

Routes through towns and cities may be changed as directed by the Local Authorities.

Restriction: Subject to the condition that no intermediate passengers may be conveyed between Newcastle and Richards Bay, both points inclusive.

SERVICE 25: JOHANNESBURG — MESSINA

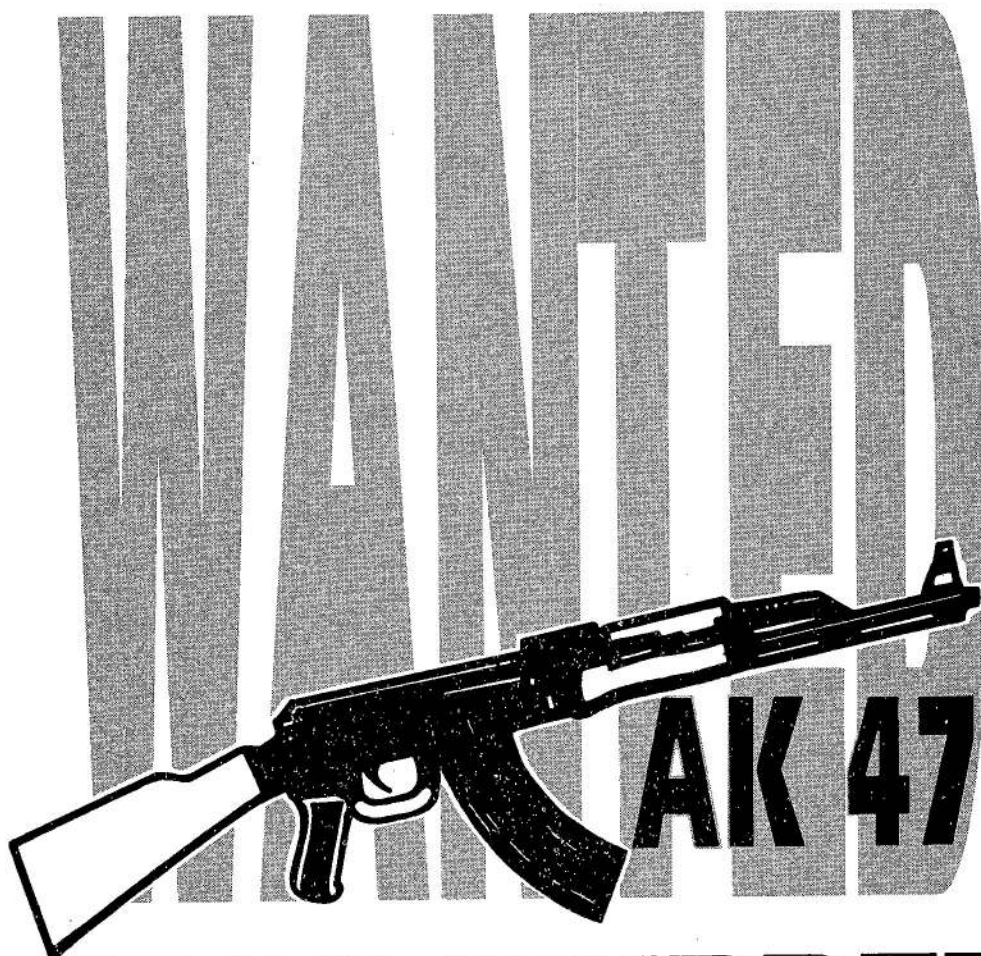
