PROHIBITION ON POSSESSION OF UNDESIRABLE PUBLICATION OR OBJECT

A Committee referred to in section 4 of the Publications Act, 1974 (the Act), which decided under section 11 (2) of the Act that the undermentioned publication is undesirable within the meaning of section 47 (2) of the Act, has under section 9 (3) of the Act prohibited the possession of the said publication. A Committee of Publications referred to in section 4 of the Publications Act, 1974 (the Act), which has decided in terms of section 11 of the Act that the undermentioned publications are not undesirable within the meaning of section 47 (2) of the Act, has in terms of section 9 (1) of the Act declared that every subsequent edition of the said publications will be subject to the conditions—

that the publications may not knowingly be sold, hired or lent out by lending libraries to persons under the age of 18 years; and

that the publications for purposes of distribution may only be displayed and distributed in a sealed plastic wrapping.
