NOTICE BY THE STATE PRESIDENT OF THE
REPUBLIC OF SOUTH AFRICA

NOTICE OF TEMPORARY IMMUNITY UNDER THE
INDEMNITY ACT, 1990 (ACT NO. 35 OF 1990)

Whereas I am of the opinion that it is necessary for the promotion of peaceful constitutional solutions in South Africa, I hereby under the power vested in me by section 1 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), unconditionally grant to the persons specified in the Schedule, immunity referred to in section 1 (2) of the aforementioned Act for the period from 19 February 1994 up to and including 17 May 1994.

Given under my Hand and the Seal of the Republic of South Africa at Cape Town this Eighteenth day of February, One thousand Nine hundred and Ninety-four.
