By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Pieter Gabriel Marais, Minister of National Education, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

1. THE PROPERTY WITH THE ST STEPHEN'S ANGLICAN CHURCH THEREON, IN MCKENZIE STREET, VRYBURG

Description

The property with the St Stephen's Anglican Church thereon, being the Remaining Extent of Erf 185, Vryburg, situated in the Municipality and Division of Vryburg, in extent 2 285 (two thousand two hundred and eighty-five) square metres.

2. THE OLD ST AUGUSTINE'S ANGLICAN CHURCH, NOW KNOWN AS THE "AFRIKAANSE PROTESTANTE KERK", WITH THE PROPERTY ON WHICH IT IS SITUATED, BEING ERF 1118, FRASERBURG
