## ALGEMENE KENNISGEWING

### KENNISGEWING 692 VAN 1994

#### ONAFHANKLIKE VERKIESINGSKOMMISSIE

Dit word hierby ingevolge artikel 124 (9) van die Grondwet van die Republiek van Suid-Afrika, 1993 (Wet No. 200 van 1993) (hierna die Grondwet genoem), bekendgemaak dat 'n versoekskrif van die African National Congress ontvang is, waarin versoek word dat die geaffekteerde gebied van Mt Currie distrik uitgesluit word van die provinsie KwaZulu/Natal en ingesluit word by die provinsie Oos-Kaap.

Aandag word gevestig op die volgende:

Ingevolge artikel 124 (10) van die Grondwet kan 'n versoekskrif binne vyf maande na die datum van hierdie kennisgewing by die Sekretaris van die Parlement ingedien word, waarin versoek word dat 'n referendum om die sienswyse van die kiesers te bepaal gehou word in die gebied ten opsigte waarvan die kennisgewing gepubliseer is. Die getal handtekeninge ingevolge artikel 124 (3) (c) van die Grondwet vir 'n versoekskrif ingevolge voormelde artikel moet gelyk wees aan 20% van die getal stemme wat in die verkiesing van die provinsiale wetgewer uitgebring is.

Indien 'n versoekskrif vir 'n referendum by die Sekretaris van die Parlement ingedien word, vervat die versoekskrif wat by die Onafhanklike Verkiezingskommissie ingedien is ingevolge die bepalings van artikel 124 (11) van die Grondwet en is die uitslag van die referendum beslissend.

Indien 'n versoekskrif vir 'n referendum nie by die Sekretaris van die Parlement ingedien word nie, word die verandering beoog in hierdie kennisgewing ooreenkomstig die bepalings van artikel 124 (12) van die Grondwet op die wyse voorgeskryf in artikel 124 (13) van daardie Wet, geïmplementeer.

## GENERAL NOTICE

### NOTICE 692 OF 1994

#### INDEPENDENT ELECTORAL COMMISSION

Notice is hereby given in terms of section 124 (9) of the Constitution of the Republic of South Africa, 1993 (Act No. 200 of 1993) (hereinafter called the Constitution), that a petition has been received from the African National Congress, requesting that the affected area of Mt Currie District be excluded from the Province of KwaZulu/Natal and be included in the Province of the Eastern Cape.

Attention is drawn to the following:

In accordance with section 124 (10) of the Constitution, a petition may be lodged with the Secretary to Parliament within five months of the date of this notice requesting that a referendum, to determine the views of the voters, be held in the area in respect of which this notice is published. The number of signatures in terms of section 124 (3) (c) of the Constitution for a petition in terms of the afore-mentioned section must be equal to 20% of the number of votes which were cast in the election of the provincial legislature.

If a petition for a referendum is lodged with the Secretary to Parliament, the petition lodged with the Independent Electoral Commission will lapse in accordance with the provisions of section 124 (11) of the Constitution, and the result of the referendum will be decisive.

If a petition for a referendum is not lodged with the Secretary to Parliament, the change contemplated in this notice will, in accordance with the provisions of section 124 (12) of the Constitution and in the manner prescribed in section 124 (13) of that Act, be implemented.
