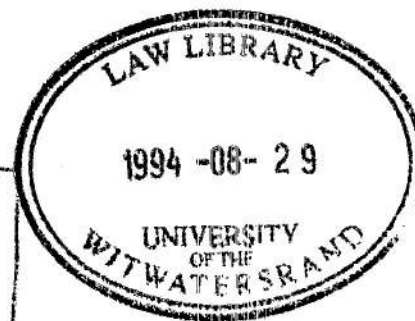

## DEREGISTRATION OF COMPANIES
