

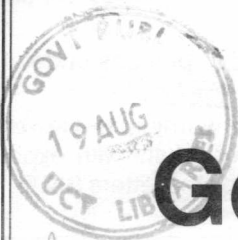

- (b) that the distributor issue a warning to viewers, indicating that it is a film for adults with explicit sex and nudity as indicated by the letters SN.
