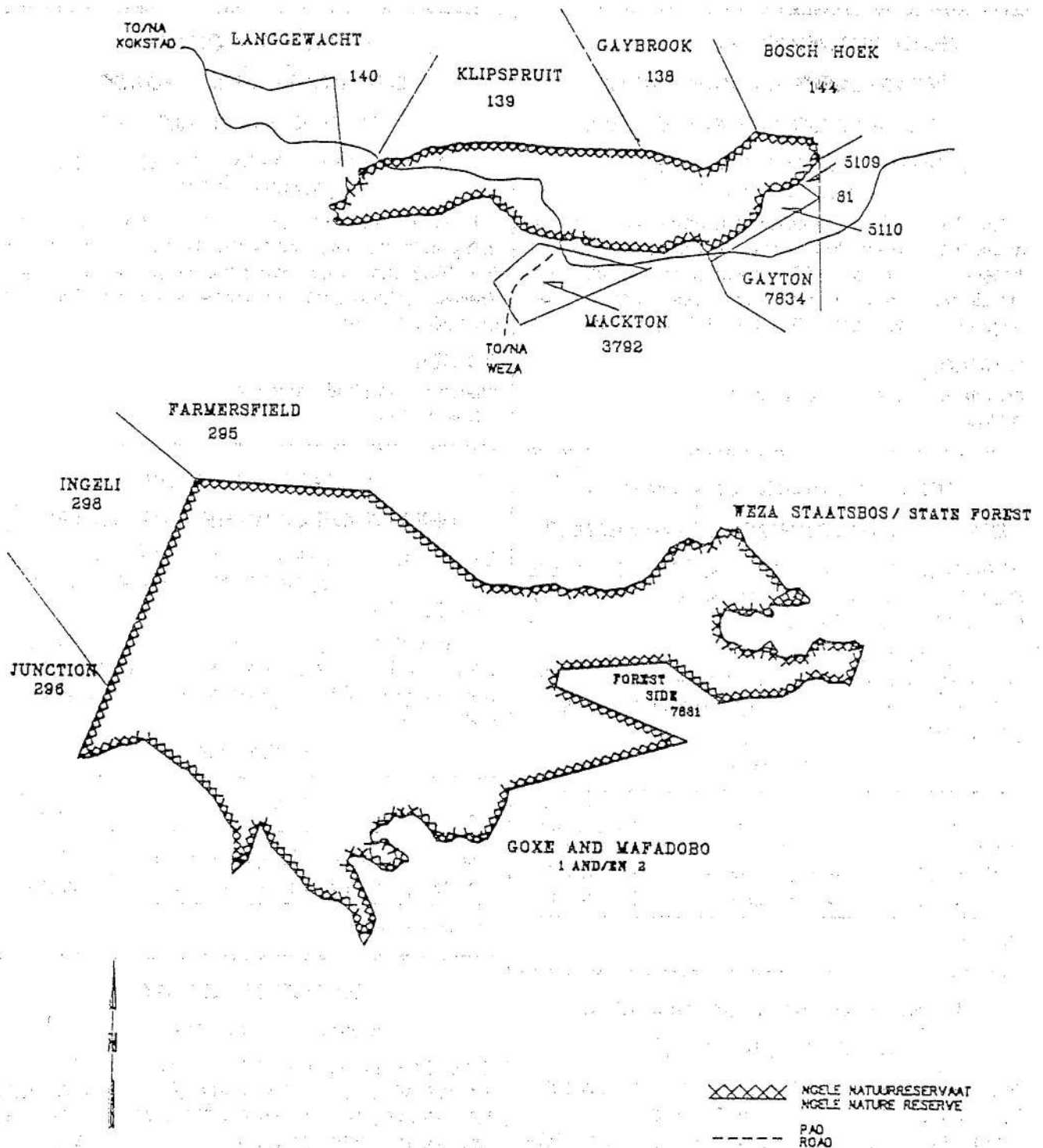
SETTING ASIDE OF A NATURE RESERVE

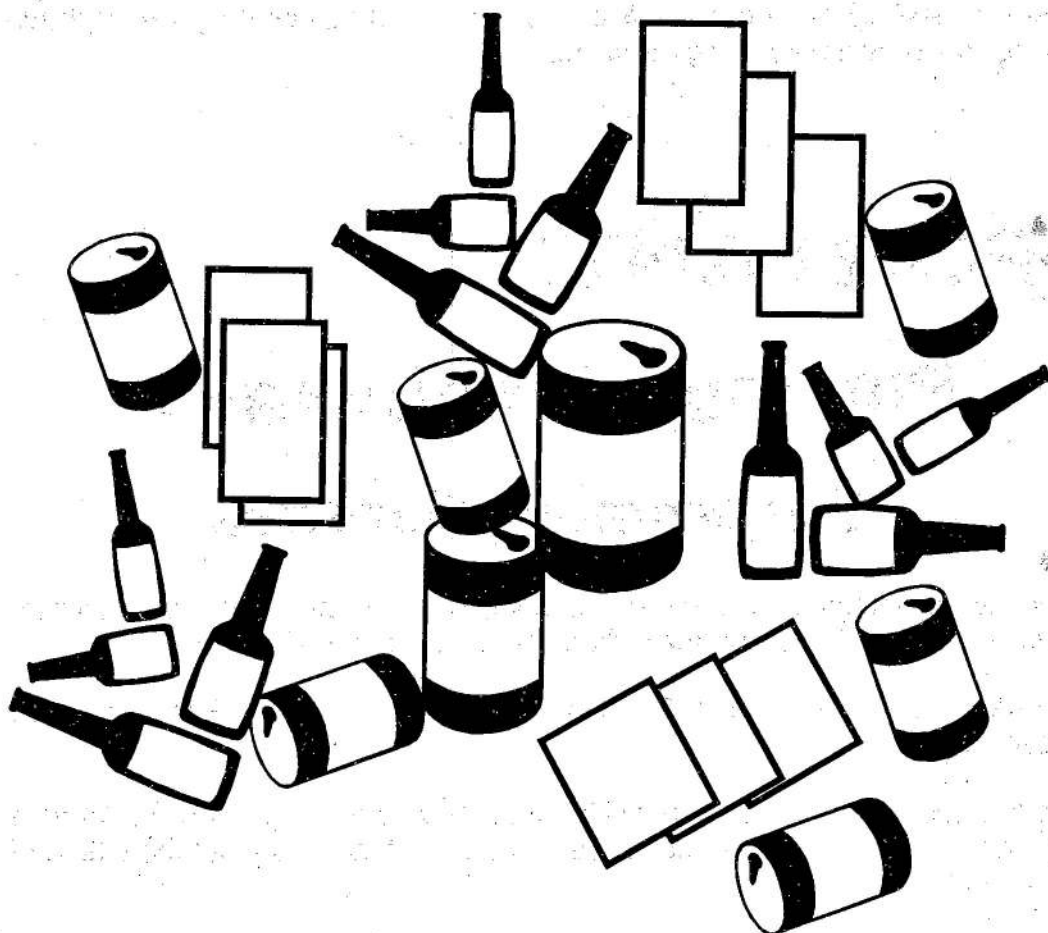
