AMENDMENT OF PUBLIC SERVICE LABOUR  
RELATIONS ACT, 1994

### Amendment of section 9 of Act of 1994

1. Section 9 of the Afrikaans text of the principal Act is hereby amended by the substitution for paragraph (i) of subsection (1) of the following paragraph:

"(i) die prosedure vir die behandeling van geskille wat binne of buite die kamer tussen die partye van die kamer ontstaan, met inbegrip van bemiddeling en vrywillige arbitrasie;"

“(3) For the purposes of subsection (2), a founding meeting shall, after reasonable notice to the employee organisations referred to in subsection (7) (b) be held, and the employer shall appoint a Chairperson to preside at that meeting, but such a Chairperson shall have no vote.”

WYSIGING VAN DIE WET OP DIE STAATSDIENS-KOMMISSIE, 1984

**Wysiging van artikel 4 van Wet van 1984**

1. Artikel 4 van die Wet op die Staatsdienskommissie, 1984, word hierby gewysig deur die byvoeging van die volgende subartikel:

“(5) Nieteenstaande enige bepalings van hierdie Wet of enige ander wet word 'n lid van die Kommissie wat 'n rustende lid, soos bedoel in artikel 15 (1) (a) van die Algemene Pensioenwet, 1979 (Wet No. 29 van 1979), van 'n pensioenfonds is, op die datum waarop sy of haar diens as lid van die Kommissie om watter rede ook al, behalwe dood, eindig, geag die aftreeleeftyd bedoel in artikel 15 (4) (e) (i) van die Algemene Pensioenwet, 1979, te bereik het.”.

AMENDMENT OF PUBLIC SERVICE COMMISSION ACT, 1984

**Amendment of section 3 of Act of 1984**

1. Section 3 of the Public Service Commission Act, 1984, is hereby emended by the substitution in paragraph (a) of subsection (1) for the word “chairman” of the word “chairperson”.

**Amendment of section 4 of Act of 1984**

1. Section 4 of the Public Service Commission Act, 1984, is hereby amended by the addition of the following subsection:

“(5) Notwithstanding any provision of this Act or any other law a member of the Commission who is a dormant member, as contemplated in section 15 (1) (a) of the General Pensions Act, 1979 (Act No. 29 of 1979), of a pension fund shall, on the date on which his or her services as a member of the Commission terminate for any reason whatsoever, except death, be deemed to have attained the retirement age referred to in section 15 (4) (d) (i) of the General Pensions Act, 1979.”.
