The Publications Appeal Board has decided under section 15 (6) of the Publications Act, 1974 (the Act), that the undermentioned publication is not undesirable within the meaning of section 47 (2) of the said Act, subject to conditions—

that the publication may not knowingly be sold, hired or lent out by lending libraries to persons under the age of 18 years;

that the publication may only be displayed and distributed in a sealed plastic wrapping and with clear "adults only" warning.
