The Publications Appeal Board has under section 24 of the Publications Act, 1974, as amended, decided that the undermentioned films are not undesirable within the meaning of section 47 (2) of the Act by stipulating—

- (a) that the films may not be exhibited to persons under 18 years of age; and
- (b) that the distributor issue a warning to viewers, indicating that the films are for adults with explicit sex and nudity as indicated by the letter SN.
