WET

Tot wysiging van die Wet op Drukkersname, 1993, ten einde die drukker van 'n nuusblad te verplig om sy of haar naam en die adres van sy of haar besigheid op die nuusblad aan te bring; om voorsiening te maak dat die Wet op Drukkersname, 1993, ook van toepassing is in die gebiede van die voormalige Republieke van Transkei, Bophuthatswana, Venda en Ciskei; om sekere wette te herroep; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Vervanging van artikel 2 van Wet 43 van 1993

1. Artikel 2 van die Wet op Drukkersname, 1993, word hierby deur die volgende artikel vervang: 5

"Aangee van naam van drukker en adres van sy of haar saak op sekere drukwerk

(1) Behoudens subartikel (2) moet 'n drukker van drukwerk **[wat nie 'n nuusblad soos omskryf in artikel 1 van die Wet op die Registrasie van Nuusblaaie, 1971 (Wet No. 63 van 1971), is nie]** op alle sodanige drukwerk wat in die Republiek voortgebring en versprei word, in leesbare letters en in **[een] enige** van die amptelike tale van die Republiek, 'n kennisgewing aanbring wat die woorde bevat 'Gedruk deur ...', gevvolg deur sy of haar volledige en juiste naam en die volledige en juiste adres waar hy sy of sy haar drukkerssaak dryf, of 'n afkorting van sy of haar naam wat ingevolge artikel 3 geregistreer is. 10

(2) Subartikel (1) is nie van toepassing op 'n drukker van drukwerk wat nie vir openbare verkoop of openbare verspreiding bestem is nie.".

Herroeping van artikels 8 tot en met 15 van Wet 43 van 1993

2. Artikels 8 tot en met 15 van die Wet op Drukkersname, 1993, word hierby herroep. 20

ACT

To amend the Imprint Act, 1993, so as to oblige the printer of a newspaper to affix his or her name and the address of his or her business on the newspaper; to provide that the Imprint Act, 1993, shall also apply in the territories of the former Republics of Transkei, Bophuthatswana, Venda and Ciskei; to repeal certain laws; and to provide for matters connected therewith.

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Substitution of section 2 of Act 43 of 1993

1. The following section is hereby substituted for section 2 of the Imprint Act, 5 1993:

“Notification of name of printer and address of his or her business on certain printed matter

10 (1) Subject to subsection (2) any printer of printed matter **[other than a newspaper as defined in section 1 of the Newspaper Registration Act, 1971 (Act No. 63 of 1971)]** shall affix on all such printed matter produced and distributed in the Republic, a notice in legible type and in **[either]** any of the official languages of the Republic, containing the words ‘Printed by ...’, followed by his or her full and correct name and the full and correct address at which he or she conducts his or her business of printing, or an abbreviation of his or her name registered in terms of section 3.

15 (2) Subsection (1) shall not apply to a printer of printed matter not intended for public sale or public distribution.”.

Repeal of sections 8 to 15 inclusive of Act 43 of 1993

20 2. Sections 8 to 15 inclusive of the Imprint Act, 1993, are hereby repealed.

Toepassing van Wet 43 van 1993

3. Die Wet op Drukkersname, 1993 (Wet No. 43 van 1993), is, vanaf die datum van inwerkingtreding van die Wysigingswet op Drukkersname, 1994, ook van toepassing in die gebiede van die voormalige Republieke van Transkei, Bophuthatswana, Venda en Ciskei. 5

Herroeping van wette

- 4.** (1) Die volgende wette word hierby herroep:
- (a) Die Wet op die Registrasie van Nuusblaale, 1971 (Wet No. 63 van 1971), van die voormalige Republiek van Suid-Afrika; 10
 - (b) Die Wet op die Registrasie van Nuusblaale en Drukkersname, 1977 (Wet No. 19 van 1977), van die voormalige Republiek van Transkei;
 - (c) Die Wet op die Registrasie van Nuusblaale en Drukkersname, 1979 (Wet No. 18 van 1979), van die voormalige Republiek van Bophuthatswana;
 - (d) Die Wysigingswet op die Registrasie van Nuusblaale en Drukkersname, 1979 (Wet No. 58 van 1979), van die voormalige Republiek van Bophuthatswana; 15
 - (e) Die Wet op die Registrasie van Nuusblaale en Drukkersname, 1981 (Wet No. 22 van 1981), van die voormalige Republiek van Venda;
 - (f) Die Wet op die Registrasie van Nuusblaale en Drukkersname, 1971 (Wet No. 63 van 1971), van die voormalige Republiek van Ciskei. 20

(2) Die verwysing na die voormalige Republiek van Suid-Afrika in subartikel (1) word uitgelê as 'n verwysing na die gebied van die Republiek van Suid-Afrika soos dit onmiddellik voor die inwerkingtreding van die Grondwet was.

- 5.** Hierdie Wet heet die Wysigingswet op Drukkersname, 1994.

Application of Act 43 of 1993

3. The Imprint Act, 1993 (Act No. 43 of 1993), shall, from the date of commencement of the Imprint Amendment Act, 1994, also apply in the territories of the former Republics of Transkei, Bophuthatswana, Venda and 5 Ciskei.

Repeal of laws

4. (1) The following laws are hereby repealed:
- (a) The Newspaper Registration Act, 1971 (Act No. 63 of 1971), of the former Republic of South Africa;
 - 10 (b) The Newspaper and Imprint Registration Act, 1977 (Act No. 19 of 1977), of the former Republic of Transkei;
 - (c) The Newspaper and Imprint Registration Act, 1979 (Act No. 18 of 1979), of the former Republic of Bophuthatswana;
 - 15 (d) The Newspaper and Imprint Registration Amendment Act, 1979 (Act No. 58 of 1979), of the former Republic of Bophuthatswana;
 - (e) The Newspaper and Imprint Registration Act, 1981 (Act No. 22 of 1981), of the former Republic of Venda;
 - (f) The Newspaper and Imprint Registration Act, 1971 (Act No. 63 of 1971), of the former Republic of Ciskei.
- 20 (2) The reference to the former Republic of South Africa in subsection (1) shall be construed as a reference to the territory of the Republic of South Africa as it was immediately before the commencement of the Constitution.

Short title

5. This Act shall be called the Imprint Amendment Act, 1994.
