It is hereby notified that the President has assented to the following Act, which is hereby published for general information:

No. 28 of 1994: Shipping and Civil Aviation Laws Rationalisation Act, 1994.

WET

Om sekere wette betreffende skeepvaart en burgerlugvaart te herroep; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Toepassing

1. Hierdie Wet, en die wette vermeld in Bylae B, is van toepassing dwarsdeur die Republiek. 5

Herroeping van wette

2. (1) Die wette in die eerste kolom van Bylae A vermeld, word hierby herroep in die mate in die tweede kolom daarvan aangedui.

(2) 'n Wet beoog in artikel 2 van die Wet op die Status van die Transkei, 1976 (Wet No. 100 van 1976), artikel 2 van die Wet op die Status van Bophuthatswana, 1977 (Wet No. 89 van 1977), artikel 2 van die Wet op die Status van Venda, 1979 (Wet No. 107 van 1979), en artikel 2 van die Wet op die Status van Ciskei, 1981 (Wet No. 110 van 1981), wat steeds in enige gebied van krag is en wat nie in Bylae A vermeld word nie, word hierby herroep in die mate waarin daardie wet strydig is met, of verwys na 'n aangeleentheid waarmee gehandel word in, 'n wet in Bylae B vermeld. 10 15

Oorgangsbepalings

3. (1) 'n Licensie, sertificaat, permit of magtiging wat uitgereik of toegestaan was ingevolge 'n wet wat by artikel 2 herroep is, word geag uitgereik of toegestaan te gewees het ingevolge die bepalings van die ooreenstemmende wet in Bylae B vermeld en bly van krag onderworpe aan die voorwaardes waaronder dit uitgereik of toegestaan is en vir die tydperk waarvoor dit uitgereik of toegestaan is of vir 'n tydperk van hoogstens ses maande vanaf die datum van inwerkingtreding van hierdie Wet, welke tydperk ook al die kortste is. 20

(2) 'n Raad of liggaaam ingestel by of ingevolge 'n wet wat by artikel 2 herroep is, hou by die inwerkingtreding van hierdie Wet op om te bestaan, waarna die lede van so 'n raad of liggaaam nie geregtig is om enige verdere vergoeding of toelaes te ontvang uit hoofde van die amp wat hulle ingevolge daardie wet beklee het nie. 25

Kort titel en inwerkingtreding

4. Hierdie Wet heet die Wet op Rasionalisering van Wette Betreffende Skeepvaart en Burgerlugvaart, 1994, en tree in werking op 'n datum deur die President by proklamasie in die Staatskoerant bepaal. 30

ACT

To repeal certain laws relating to shipping and civil aviation; and to provide for matters connected therewith.

(Assented to 23 November 1994.)*

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Application

1. This Act and the laws mentioned in Schedule B shall apply throughout the
5 Republic.

Repeal of laws

2. (1) The laws mentioned in the first column of Schedule A are hereby repealed to the extent indicated in the second column thereof.
(2) Any law contemplated in section 2 of the Status of the Transkei Act, 1976
10 (Act No. 100 of 1976), section 2 of the Status of Bophuthatswana Act, 1977 (Act No. 89 of 1977), section 2 of the Status of Venda Act, 1979 (Act No. 107 of 1979), and section 2 of the Status of Ciskei Act, 1981 (Act No. 110 of 1981), which is still in force in any area and which is not mentioned in Schedule A, is hereby repealed to the extent to which that law is in conflict with, or refers to a
15 matter dealt with in, a law mentioned in Schedule B.

Transitional provisions

3. (1) Any licence, certificate, permit or authorisation issued or granted in terms of a law repealed by section 2, shall be deemed to have been issued or granted in terms of the provisions of the corresponding law mentioned in
20 Schedule B and shall remain in force subject to the conditions under which it was issued or granted and for the period for which it was issued or granted or for a period not exceeding six months as from the date of commencement of this Act, whichever period is the shorter.
(2) Any board, council or body instituted by or in terms of a law repealed by
25 section 2 shall cease to exist at the commencement of this Act, whereafter the members of such a board, council or body shall not be entitled to receive any further remuneration or allowances by virtue of their appointment to that board, council or body.

Short title and commencement

- 30 4. This Act shall be called the Shipping and Civil Aviation Laws Rationalisation Act, 1994, and shall come into operation on a date fixed by the President by proclamation in the *Gazette*.
