WET

Om voorsiening te maak vir die rasionalisering van sekere wette met betrekking tot bosbou-aangeleenthede wat uit hoofde van artikel 229 van die Grondwet van krag gebly het in verskeie gebiede van die nasionale grondgebied van die Republiek; om die Wet op die Wattelbasnywerheid, 1960, te wysig ten einde sekere uitdrukkings te heromskryf; om die Boswet, 1984, te wysig ten einde sekere uitdrukkings te heromskryf; en om sekere verouderde bepalings te skrap; om die Wet op die Bestuur van Staatsbosse, 1992, te wysig ten einde 'n sekere uitdrukking te heromskryf; en om voorsiening te maak vir aangeleenthede wat daarmee in verband staan.

DAAR WORD BEPAAL deur die Parlement van die Republiek van Suid-Afrika, soos volg:—

Herroeping van wette, en voorbehoude

1. (1) Behoudens die bepalings van subartikel (2) word die wette genoem in die tweede kolom van Bylae 1 hierby herroep soos aangedui in die derde kolom van Bylae 1 en in Bylae 2, in die mate waarin sodanige wette van krag was onmiddellik voor die datum van inwerkingtreding van die Grondwet in die onderskeie gebiede van die nasionale grondgebied van die Republiek soos uiteengesit in die vierde kolom van Bylae 1. 5

(2) Enigiets wat gedoen is kragtens 'n wet genoem in die tweede kolom van Bylae 1 en wat kragtens 'n bepaling van 'n wet genoem in die tweede kolom van Bylae 3 gedoen kan word, word geag kragtens sodanige bepaling van sodanige wet gedoen te wees. 10

Uitbreiding van toepassing van sekere wette

2. (1) Behoudens die bepalings van subartikel (2) is die wette genoem in die tweede kolom van Bylae 3 wat onmiddellik voor die datum van inwerkingtreding van die Grondwet van krag was in die nasionale grondgebied van die Republiek, met die uitsondering van die gebiede van die nasionale grondgebied uiteengesit in die vierde kolom van Bylae 1, vanaf die datum van inwerkingtreding van hierdie Wet ook van toepassing ten opsigte van al die gebiede van die nasionale grondgebied uiteengesit in die vierde kolom van Bylae 1, in die mate aangedui in die derde kolom van Bylae 3. 15 20

ACT

To provide for the rationalisation of certain laws relating to forestry matters that remained in force in various areas of the national territory of the Republic by virtue of section 229 of the Constitution; to amend the Wattle Bark Industry Act, 1960, so as to redefine certain expressions; to amend the Forest Act, 1984, so as to redefine certain expressions; and to delete certain obsolete provisions; to amend the Management of State Forests Act, 1992, so as to redefine a certain expression; and to provide for matters connected therewith.

(Assented to 23 November 1994.)

BE IT ENACTED by the Parliament of the Republic of South Africa, as follows:—

Repeal of laws, and savings

1. (1) Subject to the provisions of subsection (2), the laws mentioned in the second column of Schedule 1 are hereby repealed as indicated in the third column of Schedule 1 and in Schedule 2, to the extent that such laws were in force in the various areas of the national territory of the Republic as set out in the fourth column of Schedule 1 immediately prior to the date of commencement of the Constitution.
- (2) Anything done under a law mentioned in the second column of Schedule 1 and which is capable of being done under a provision of a law mentioned in the second column of Schedule 3, shall be deemed to have been done under such provision of such law.

Extension of application of certain laws

2. (1) Subject to the provisions of subsection (2), the laws mentioned in the second column of Schedule 3 which immediately prior to the date of commencement of the Constitution were in force in the national territory of the Republic, excluding the areas of the national territory set out in the fourth column of Schedule 1, shall, from the date of commencement of this Act, also apply in respect of all the areas of the national territory set out in the fourth column of Schedule 1, to the extent indicated in the third column of Schedule 3.
- (2) Notwithstanding the provisions of subsection (1), the provisions of Part

(2) Subartikel (1) tree in werking op 'n datum deur die President by proklamasie in die *Staatskoerant* bepaal.

(3) (a) Die Minister van Waterwese en Bosbou moet 'n komitee bestaande uit drie beamptes van die Departement van Waterwese en Bosbou aanstel, van wie een deur die Minister as voorsitter van die komitee aangewys word, om hom of haar van 'n verslag te voorsien met betrekking tot die ontbinding van die "Transkei Forestry Council". 10

(b) Na oorweging van die komitee se verslag beoog in paragraaf (a), kan die Minister van Waterwese en Bosbou sodanige bevel met betrekking tot die bates en laste van die "Transkei Forestry Council" maak as wat hy of sy, met die instemming van die Minister van Finansies, en na oorlegpleging met die Bosbouraad waarna verwys word in artikel 47 van die Boswet, 1984 (Wet No. 122 van 1984), goeddink. 15

(4) (a) Die Minister van Waterwese en Bosbou kan vir die doeltreffende uitvoering van die "Forestry Council Act", 1984 (Wet No. 15 van 1984) (Transkei), voor die datum beoog in subartikel (2), by kennisgewing in die *Staatskoerant* genoemde Wet wysig of aanpas ten einde die aanwending of interpretasie daarvan te reël en ten einde die "Transkei Forestry Council" opnuut saam te stel. 20 25

(b) Die Minister van Waterwese en Bosbou kan te eniger tyd 'n kennisgewing waarna verwys word in paragraaf (a), by wyse van 'n soortgelyke kennisgewing in die *Staatskoerant* wysig of herroep.

FORESTRY LAWS RATIONALISATION AND AMENDMENT ACT, 1994 Act No. 51, 1994

VIII of the Forest Act, 1984 (Act No. 122 of 1984), mentioned in the second column of Schedule 3, shall apply in respect of the territory of the former Republic of Transkei, from the date contemplated in section 3(2) of this Act.

Repeal of Act 15 of 1984 (Transkei)

5 3. (1) Subject to the provisions of this section, the Forestry Council Act, 1984 (Act No. 15 of 1984) (Transkei), is hereby repealed.

(2) Subsection (1) shall commence on a date determined by the President by proclamation in the *Gazette*.

10 (3) (a) The Minister of Water Affairs and Forestry shall appoint a committee consisting of three officers of the Department of Water Affairs and Forestry, one of whom shall be designated by the Minister as chairperson of the committee, to furnish him or her with a report on the winding up of the affairs of the Transkei Forestry Council.

15 (b) After consideration of the report of the committee, contemplated in paragraph (a), the Minister of Water Affairs and Forestry may make such order with regard to the assets and liabilities of the Transkei Forestry Council as he or she, with the concurrence of the Minister of Finance, and after consultations with the Forestry Council referred to in section 47 of the Forest Act, 1984 (Act No. 122 of 1984), deems fit.

20 (4) (a) The Minister of Water Affairs and Forestry may for the efficient carrying out of the Forestry Council Act, 1984 (Act No. 15 of 1984) (Transkei), prior to the date contemplated in subsection (2), by notice in the *Gazette*, amend or adapt the said Act to regulate its application or interpretation and to reconstitute the Transkei Forestry Council.

25 (b) The Minister of Water Affairs and Forestry may at any time amend or withdraw a notice referred to in paragraph (a) by like notice in the *Gazette*.

SCHEDULE 2**EXTENT OF REPEAL OF CERTAIN LAWS****1. Trust Forest Regulations, 1967 (Proclamation R.191 of 1967)**

Regulations 9 to 26 inclusive, only in so far as they relate to land set aside as a reserved forest or plantation under Regulation 6.

2. Transkei Forest Act, 1969

Except—

- (a) section 2(1)(l) in so far as it relates to the protection of trees on land which is not a Government forest;
