PUBLICATIONS ACT, 1974 FILM

WET OP PUBLIKASIES, 1974 ROLPRENT

The Publications Appeal Board has under section 24 of the Publications Act, 1974, as amended, decided that the undermentioned film is not undesirable within the meaning of section 47 (2) of the Act by stipulating—

- (a) dat dit nie aan persone onder die ouderdom van 18 jaar (R18) vertoon mag word nie; en
- (b) dat die verspreider in 'n waarskuwing aan kykers, aandui dat hierdie rolprent vir volwassenes is, vanweë eksplisiete sekstonele, naaktheid, kru taal en geweld soos aangedui deur die letters SNLV.
