UNEMPLOYMENT INSURANCE ACT, 1966

INCREASE OF THE MAXIMUM RATE OF EARNINGS
BY VIRTUE OF WHICH A PERSON QUALIFIES AS A
CONTRIBUTOR

Under section 2 (2) (d) of the Unemployment Insurance Act, 1966 (Act No. 30 of 1966), I, Tito Mboweni, Minister of Labour, hereby amend the rate of earnings referred to in Government Notice No. 2528 of 31 December 1993, from sixty-three thousand six hundred and forty-eight rand per annum to sixty-nine thousand four hundred and twenty rand per annum with effect from 1 April 1995.
