NOTICE OF THE PRESIDENT OF THE REPUBLIC OF SOUTH AFRICA

NOTICE OF INDEMNITY UNDER THE INDEMNITY ACT, 1990 (ACT No. 35 OF 1990)

Under the powers vested in me by section 2 (1) of the Indemnity Act, 1990 (Act No. 35 of 1990), I hereby grant to any person who before 6 December 1993 was in possession of any firearm, ammunition, explosive or explosive device in contravention of the provisions of any law that regulates the possession of such firearm, ammunition, explosive or explosive device, indemnity in respect of such possession if the possession of such firearm, ammunition, explosive or explosive device was associated with a political objective relating to the conflicts of the past.

Given under my Hand and the Seal of the Republic of South Africa at Pretoria this Twenty-first day of April, One thousand Nine hundred and Ninety-five.
