The Publications Appeal Board under section 24 of the Publications Act, 1974, as amended, has decided that the video version of the undermentioned film is not undesirable within the meaning of section 47 (2) of the Act by stipulating—

(a) that it may not be exhibited to persons under 18 years (R18); and

(b) that the distributor issue a warning to viewers, indicating that it is for adults, with explicit sex and nudity as indicated by the letters SN; and

(c) that the theatrical version be submitted de novo to a Committee of Publications for a decision.

(a) dat dit nie aan persone onder die ouderdom van 18 jaar (R18) vertoon mag word nie; en

(b) dat die verspreider in 'n waarskuwing aan kykers, aandui dat dit vir volwassenes is, vanweë eksplisiete sekstonele en naaktheid soos aangedui deur die letters SN; en

(c) dat die teaterweergawe de novo aan 'n Komitee van Publikasies voorgelê word vir 'n beslissing.
